

The CITY GOVERNMENT OF BACOOR, a local government unit duly organized and existing under the laws of the Republic of the Philippines, with its principal office address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Province of Cavite, represented herein by its City Mayor, Hon. STRIKE B. REVILLA, pursuant to his authority conferred and embodied in City Resolution No.

Series of 2025, approved by the City Council of Bacoor dated

, and hereinafter referred to as "DONOR"

and

The BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) CALABARZON, with office address at Barangay Turbina, Calamba, Laguna, represented herein by its Regional Director, JCSUPT. HILBERT M. FLOR, MPSA, hereinafter referred to as the "DONEE"

WITNESSETH THAT

WHEREAS, the DONOR is a local government unit which shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare under the Local Government Code of 1991;

WHEREAS, one of the DONOR's initiatives to uphold law and order in the City of Bacoor's jail and detention facilities is the acquisition, donation, and purchase of assault rifles and pistols. This would greatly improve their equipment and general capacity to manage, oversee, and administer the city's jails, which are charged with the dual duties of providing for the development and safety of their inmates, who are formally classified as persons deprived of liberty (PDL):

WHEREAS, the DONEE, a law enforcement organization in the City of Bacoor, is essential to the supervision and management of the city jails, as well as the advancement of PDLs' overall welfare and safety;

WHEREAS, the donation is seen as a demonstration of the DONOR's dedication to aiding the DONEE in their goal of providing efficient management and oversight of the city's jail facilities in addition to strengthening the equipment at the BJMP - Bacoor City Female Dormitory;

NOW, THEREFORE, the DONOR hereby voluntarily and freely gives, transfers, and conveys by way of donation unto said DONEE all of its right, title. and interest over the abovementioned properties.

That as part of DONEE's commitment to the delivery of genuine public service consistent with the plans and programs of the DONOR, the latter, as an act of liberality and generosity, hereby voluntarily GIVES, TRANSFERS, and CONVEYS by way of donation unto the DONEE the above-described items;

The DONEE, with appreciation and gratitude, hereby accepts this donation subject to the following terms and conditions:

- 1. The said assault rifles shall be used by the DONEE solely within the territorial jurisdiction of the City of Bacoor;
- The donated items shall be exclusively and equally utilized by the BJMP. - Bacoor City Female Dormitory;
- 3. The DONEE shall be in charge of properly storing, maintaining, and preserving the rifles in good and pristine condition; and
- 4. The assault rifles and pistol 9MM shall not be used or otherwise disposed of in any unlawful manner or in violation of pertinent laws and ordinances.

The said donation is subject to Section 76 of Presidential Decree (PD) No. 1445, otherwise known as the Government Auditing Code of the Philippines, and Part IV, V.4, and VII of Commission on Audit (COA) Circular No. 89-926 dated 27 January 1989.

In case the DONEE fails to comply with the above-cited terms and conditions, Article 764 of the Civil Code of the Philippines shall apply, to wit:

> "Article 764. The donation shall be revoked at the donor's instance when the donee fails to comply with any of the conditions that the former imposed upon the latter.

> In this case, the property donated shall be returned to the donor x x x

> > XXX."

Thus, the donation shall be revoked at the DONOR's instance, and the property donated shall be returned.

The DONOR affirms that the donation is not made with the intent to deceive its creditors and that it has reserved for itself and its legal obligations sufficient funds and properties.

The DONEE hereby accepts and receives this donation made in its favor by the DONOR and hereby expresses its appreciation and gratefulness for the kindness and generosity of the DONOR in recognizing the abovementioned goods.
