Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, STRIKE B. REVILLA, TO SIGN A DEED OF SALE ON BEHALF OF THE GOVERNMENT OF BACOOR WITH MS. PRINCESITA R. BAQUIR PERTAINING TO THE SALE OF A PARCEL OF LAND LOCATED IN MOLINO, BACOOR CITY, CAVITE, WITH LOT NO. 6685 AND TAX DECLARATION NO. 2370015000233. (PCR 748-2025 dated 10 February 2025)

Acting on the proposed resolution as above-stated subject title, it was discussed during the 127th Regular Session held on 10 February 2025, the Committee Chair on Housing, Land Utilization, and Urban Development, Hon. Alde Joselito F. Pagulayan reports the following.

FINDINGS:

On 04 February 2025, the Office of the City Administrator formally requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor to enter into and sign the Deed of Absolute Sale with Princesita R. Baquir for the acquisition of a parcel of land with identified Lot No. 6685 with Tax Declaraton No. 2370015000233, situated at Barangay Molino, Bacoor City, Cavite.

The said lot is intended for the construction of a sports arena in Barangay Molino. The proposed facility will serve the general public and is aligned with the City Government's infrastructure development and public service goals.

RECOMMENDATION:

Upon due evaluation, the Committee recommends the APPROVAL of the proposed resolution. The subject transaction is deemed necessary and beneficial, as the planned construction of a sports arena will promote community wellness, youth development, and public recreation in the City of Bacoor.

The Presiding Officer, Hon. Rowena Bautista-Mendiola presided over the 127th Regular Session of the 5th Sangguniang Panlungsod on 10 February 2025.

This Deed of Sale ("Deed") is made and entered into by and between:

PRINCESITA R. BAQUIR, of legal age, Filipino, residing and with postal address at Del Pilar Street, Poblacion West, Muñoz, Nueva Ecija (hereinafter referred to as the "SELLER")

CITY GOVERNMENT OF BACOOR, a local government unit created and existing under the laws of the Republic of the Philippines, with principal office address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Province of Cavite, represented herein by its City Mayor, HON. WHEREAS, the SELLER has already settled with the Bureau of Internal Revenue (BIR) the Capital Gains Tax (CGT) and Documentary Stamp Tax (DST) due last ______;

WHEREAS, the PURCHASER has offered to purchase from the SELLER the Subject Property at PHP5,500.00/sqm based on the Latest Appraisal Report of the City Assessor's Office,⁴ subject to certain terms and conditions hereinafter set forth;

NOW, THEREFORE, for and in consideration of the foregoing premises, the payment of the purchase price, the SELLER hereby sells, transfers and conveys to the PURCHASER the Subject Property, subject to the following terms and conditions:

- The purchase price shall be PHP5,500.00/sqm, or a total of PHILIPPINE PESOS: TWO HUNDRED EIGHTY-SIX MILLION TWENTY-SEVEN THOUSAND FIVE HUNDRED AND 00/100 (PHP 286,027,500.00).
- The Parties agree that the Purchase Price shall be settled in the following schedule of payments:
 - a. the downpayment in the amount of PHILIPPINE PESOS: TWO HUNDRED FORTY MILLION AND 00/100 (PHP 240,000,000.00) by January 2025, and
 - b. the remaining balance in the amount of PHILIPPINE PESOS: FORTY-SIX MILLION TWENTY-SEVEN THOUSAND FIVE HUNDRED AND 00/100 (PHP 46,027,500.00) upon the release of the Supplemental Budget #1 FY 2025.
- Notwithstanding the foregoing, the SELLER agrees and undertakes to transfer and convey to the PURCHASER the certificate of title and tax declaration over the Subject Property upon receipt of the downpayment of the Purchase Price.
- 4. The SELLER hereby covenant and agree with the PURCHASER that the Subject Property is free from all liens and encumbrances, that she has a perfect right to convey the same, and that she will warrant and forever defend the same unto the said PURCHASER, its successors-in-interest and assigns, as the case may be, against the claims of all persons whomsoever.
- 5. The SELLER agrees to shoulder the expenses for the payment of real property taxes, capital gains tax, documentary stamp tax, transfer taxes, notarial fees, and all other fees, charges, penalties (if any), or expenses relative to or as a consequence of the transfer of the certificate of title of the Subject Property in favor of the PURCHASER.
