Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO PAY CAPITAL GAINS TAXES AND OTHER TAXES AND FEES BEING IMPOSED BY NATIONAL GOVERNMENT AGENCIES FROM THE PROCEEDS OF THE SOCIALIZED HOUSING TAX AND FROM OTHER AVAILABLE FUNDS IN ORDER TO EXPEDITE THE TRANSFER AND TITLING OF ALL PARCELS OF LAND PURCHASED BY, OR DONATED TO, THE CITY OF BACOOR UNDER THE NAME OF THE CITY GOVERNMENT. (PCR 790-2025) dated 17 March 2025)

The above-stated proposed resolution was discussed during the 132<sup>nd</sup> Regular Session on 17 March 2025. The Committee on Housing, Land Utilization, and Urban Development, chaired by Hon. Alde Joselito F. Pagulayan respectfully reports the following.

### FINDINGS:

- 1. The Sangguniang Panlungsod enacted City Ordinance No. 2013-060 on 3 December 2013, also known as the "2013 Bacoor Revenue Code." Section 16 of said ordinance provides for the imposition of a Socialized Housing Tax at a rate of one-half percent (0.5%) on the assessed value of all lands within the City in excess of Fifty Thousand Pesos (P50,000.00), in addition to the basic real property tax. This is in line with Republic Act No. 7279, or the Urban Development and Social Housing Act of 1992.
- 2. The primary purpose of this tax is to fund socialized housing projects, including the acquisition of land and housing units for underprivileged and homeless residents. as well as site development, long-term financing, and other support measures as provided by law.
- 3. In addition to purchases, the City has received donated parcels of land from private individuals and entities, intended for public infrastructure and development purposes. However, the transfer and titling of these lots have been delayed due to unpaid taxes and fees.
