Subject: LETTER FROM GAUDIER LAW OFFICE REQUESTING INTERCESSION AND ASSISTANCE IN CONNECTION WITH THE RIGHT OF WAY ISSUE IN KATAASAN ZAPOTE 2. (PCR 794-2025 dated 24 March 2025)

The above-stated subject matter was discussed during the 141st Regular Session on 26 May 2025. It was initially referred to the Committee on Housing, Land Utilization, and Urban Development, chaired by Hon. Alde Joselito F. Pagulayan, during the 133rd Regular Session on 24 March 2025.

In a letter dated 20 March 2025, the Gaudier Law Office requested intercession and assistance of the Sangguniang Panlungsod concerning a right-of-way issue in Kataasan, Zapote II

FINDINGS:

Two committee hearings were scheduled to deliberate on the matter: 25 April 2025 and 22 May 2025. However, representatives from both the Gaudier Law Office and Golden Bay Prime Landholdings, Inc. (GBPLI) failed to attend either hearing despite due notice (served via email and Viber.)

On 21 May 2025, the Committee received a letter from Pambid Cruz Law Office, the legal representative of GBPLI, stating that the matter is currently the subject of an active case pending before Branch 119 of the Regional Trial Court (RTC) of Bacoor City.

The Chair then read the subject of the hearing and proceeded to read aloud the letter emailed by Pambid Cruz Law Office (GBPLI Representative) dated 21 May 2025. The letter stated that the issue is currently the subject of an active case pending before Branch 119 of the Regional Trial Court of Bacoor City. Given the sub judice nature of the matter and in deference to the authority and jurisdiction of the Honorable Court, GBPLI is constrained to decline participation in the committee hearing. The GBPLI emphasized that all the related matters should be resolved exclusively through the proper judicial forum.

A representative from the Office of the City Legal Services Office (OCLS) was then acknowledged. It was affirmed that since the matter is under judicial consideration between Gaudier Law Office and GBPLI, the Sangguniana Panlungsod has no jurisdiction over the issue. Therefore, it was recommended that the matter be archived.

Hon. Pagulayan acknowledged the legal recommendation and moved to ARCHIVE the matter. The motion was duly seconded by the members of the Committee and the Councilors present.

With no further comments or objections, the committee hearing was ADJOURNED.

In behalf of our client several residents of Kataasan Zapote 2 Bacoor Cavite would like to express our sincerest gratitude for accommodating their representatives and granting them an audience despite your hectic schedule. However, we seek your intercession and assistance once again in connection with the above subject matter, particularly to include in the Agenda of the Sangguniang Panglunsod the current situation in their place with respect to the issue of right of way with a pending petition at the RTC Branch 119 scheduled for Pre Trial Conference last March 19, 2025 at 1:30 P.M.

To briefly appraise you of the facts of the case, Golden Bay seeks to fence the existing right of way measuring 4 meters as reflected in the residents certificates of title as perpetual easement of right of way, to a mere one meter thereby severely constricting and impeding their right of ingress and egress to the property placing the residents especially those leaving in the interior portion in serious peril in case of emergencies.

Thorough the intercession of your office, our clients would like have the matter discussed in the Agenda of the Sanggunian particularly the following:

 Maintenance of at least a 3 meter wide right of way serving as main access road to their place.

Granting of an additional 3 meter wide access road serving as the access road from their place and the interior section to the main road

 Finally for the LGU, to address their concern of an adequate drainage in the area as currently flood waters is very deep in the area (lampas tao) in the vernacular.


