Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE RENEWAL OF THE LICENSE AGREEMENT WITH THE CLUBHOUSE NETWORK ON BEHALF OF THE CITY GOVERNMENT OF BACOOR. (PCR 818-2025 dated 28 April 2025)

Acting on the proposed resolution authorizing the City Mayor to sign the renewal of the license agreement with the Clubhouse Network License Agreement during the 138th Regular Session on 28 April 2025. The Committee on Education, Science, and Technology chaired by Hon. Alde Joselito F. Pagulayan respectfully reports that.

FINDINGS:

The Bacoor Computer Clubhouse was established to provide technological access and learning opportunities to youth, particularly those without personal access to computers or the internet.

Renewing the license agreement with The Clubhouse Network will allow the Bacoor Computer Clubhouse to continue its operations and services. It will ensure that underprivileged students retain access to advanced learning tools and digital resources typically beyond their reach.

Furthermore, under existing laws and regulations, the City Mayor is authorized to sign agreements and contracts on behalf of the City Government, provided that such authority is granted in advance by the Sangguniang Panlungsod.

RECOMMENDATION:

Upon due evaluation, the Committee respectfully recommends the APPROVAL of the proposed resolution. The renewal of the agreement is essential to support educational equity and to uphold the City Government's commitment to expanding access to digital learning for economically disadvantaged students.
