Subject *A RESOLUTION DECLARING PHASE 1 OF MARIA SALUD SUBDIVISION, SALINAS 1, BACOR CITY, CAVITE AS AN OPEN COMMUNITY. (PCR 828-2025 dated 19 May 2025)*

The proposed resolution declaring Phase I of Maria Salud Subdivision, Salinas I, as an open community was discussed during the 141st Regular Session on 26 May 2025. It was initially referred to the Committee on Housing, Land Utilization, and Urban Development, chaired by Hon. Alde Joselito F. Pagulayan, during the 140th Regular Session on 19 May 2025.

FINDINGS:

During the committee hearing held on 22 May 2025, the following matters were deliberated:

The Meralco Bacoor Village Homeowners Association, Inc. (MEBAVIHA) explained that the intention behind the proposed resolution was to allow Maynilad Water Services access to the subdivision/village, thereby enabling the provision of clean water to residents who currently rely solely on deep wells.

Upon review of previous legislative records, it appears that there was a prior resolution - City Resolution No. CR 2019-019 Series of 2019, entitled:

"A RESOLUTION DECLARING MARIA SALUD VILLAGE PHASE I AND II, SALINAS I, CITY OF BACOR AS AN OPEN COMMUNITY FOR THE EXCAVATION/WATER PIPELINE INSTALLATION BY MAYNILAD WATER SERVICES, INC." (A copy is attached hereof.)

However, under Republic Act No. 11201, or the DHSUD Act of 2018, only DHSUD has the authority to declare a subdivision/village as abandoned. A mere declaration as an "open community" does not resolve the legal, administrative, and long-term governance issues related to the subdivisions that have been neglected or left unfinished by developers.





RECOMMENDATION:

Upon due deliberation and evaluation, the Committee recommends **TO PASS** a new resolution requesting DHSUD to take appropriate action to formally declare Phase I of Maria Salud Subd. Salinas I, as abandoned, in lieu of the proposed resolution declaring it as an open community.

The Committee emphasizes that the "open community" designation is not applicable in this case, since only DHSUD has the legal authority to make a formal declaration of abandonment in accordance with the DHSUD Act of 2018.

Furthermore, the Committee recommends that the Homeowners Association (MEBAVIHA) prepare and submit all necessary documentation in support of their request for a formal abandonment declaration by DHSUD.

The committee hearing was called to order by the Chairperson, Hon. Pagulayan. All attendees were requested to introduce themselves, stating their names, designations, and respective offices.

The Chair then read the title of the proposed resolution and opened the floor to the representatives of the Meralco Bacoar Village Homeowners Association, Inc. (MEBAVIHAI) to explain its purpose. According to them, the intent behind the resolution was to allow Maynilad Water Services access to the subdivision/village so that residents





could be provided with clean and reliable water, as the current source is limited to deep wells.

The Committee emphasized that declaring the area an "open community" is not applicable in this case, as such a declaration does not address the legal requirements for utility connections and long-term subdivision/village governance. Instead, what is required is a formal declaration of abandonment by the Department of Human Settlements and Urban Development (DHSUD).

Atty. Valenciano was then acknowledged. She asked whether the subdivision/village had already been officially declared abandoned by its developer and clarified that under the DHSUD Act of 2018, only DHSUD has the authority to make such a declaration. The Local Government cannot independently declare a subdivision as "abandoned."

Hon. Pagulayan agreed with this legal clarification and endorsed the preparation of a new resolution requesting DHSUD to formally declare Phase I of Maria Salud Subdivision as abandoned.

Hon. Palabrica concurred with the proposal and advised MEBAVIHAI to gather and submit all necessary documents as required by DHSUD to support the request for abandonment declaration.

Subsequently, Hon. Pagulayan moved for the APPROVAL of a new resolution requesting DHSUD to take appropriate action to formally declare Phase I of Maria Salud Subd. Salinas I, as abandoned, in lieu of the proposed resolution declaring it as an open community. The motion was duly seconded by the Committee Members and the Councilors present.

With no further comments or objections, the committee hearing was ADJOURNED.
