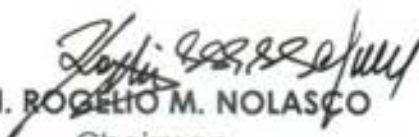
RECOMMENDATION:

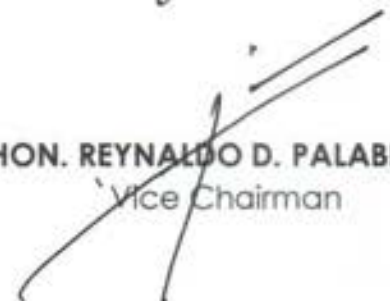

I heard that this is their first time, Ms Nieves to attend a committee hearing like this, we are very grateful na nakarating din kayo at Makita nyo ang inyong mga konsehal sa District 1."

Hon. Rogelio M. Nolasco: "In additional, first time lang din naming magkaroon ng hearing na kumpleto. Barangay Captain, Appropriation Officer, Barangay Treasurer, Secretary and Staff. Congratulations."

Hon. Reynaldo Palabrica: "With that Mr. Chair, please make it on record for the recommendations to SP Secretariat, all the appropriations office on this subject matter are presents. Pero bago natin aprubahan ang motion n gating kagalang galang na konsehal from district 1, ay hayaan muna nating marinig ang sasabihin ng mga taga Sinbanali."

Hon. Rogelio M. Nolasco: "Itatanong ko lang sa ating budget officer sa barangay pwede ba tayong mag create ng position na assistant treasurer?"
