Subject: *BARANGAY ORDINANCE NO. 1 SERIES OF 2024: An ordinance renaming the merged Barangay Talaba 1,3,7 to Zone 1, Zone 3, & Zone 7 Barangay Talaba 1.*

The above-mentioned proposed ordinance underwent its first reading on May 20, 2024 during the 91st Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Acting Presiding Officer, City Councilor and President Pro-Tempore Hon. Reynaldo C. Palabrica to the Committee on Rules and Privileges, Laws and Ordinances.

The Committee on Rules and Privileges, Laws and Ordinances sent out invitations to the resource persons and conducted a committee hearing on May 30, 2024 at the Session Hall of the Sangguniang Panglungsod at 9:00 a.m.

FINDINGS:

Pursuant to City Ordinance No. 275-2023 (An ordinance merging various barangays in the City of Bacoor, Cavite to ensure their economic growth and development, renaming the merged barangays and the barangays affected by such merger, fixing their respective territorial boundaries, and appropriating funds for the holding of a plebiscite for the approval hereof as mandated by law), a plebiscite was conducted last July 29, 2023 including the merging of Barangays Talaba 1, Talaba 3 and Talaba 7.

By virtue of Section 13 of Republic Act 7160 which provides that the sanggunians of cities and municipalities may change the names of city barangays, upon recommendation of the Sangguniang Barangay concerned, Barangay Talaba 1 proposed thru an ordinance to rename the merged Barangays Talaba 1,3, and 7 to Zone1, Zone 3 and Zone 7 Barangay Talaba 1.

**AN ORDINANCE RENAMING THE MERGED BARANGAY TALABA 1, 3 & 7 TO
ZONE 1, ZONE 3 & ZONE 7 BARANGAY TALABA 1**

WHEREAS, Section 39 (1) of the same Code provides that the Sangguniang Barangay is empowered to submit to the Sangguniang Panlungsod or Sangguniang Bayan such suggestion or recommendation as it may see fit for the improvement of the barangay or the welfare of the inhabitants thereof;

WHEREAS, the Sangguniang Barangay will make an appropriate action for the proper naming of the said merged Barangay;

WHEREAS, the said Barangay Ordinance of Barangay Talaba 1 residents became aware of the changes of the merged Barangay and renaming **ZONE 1, ZONE 3 & ZONE 7 BARANGAY TALABA 1**;

WHEREAS, on 29th day of July, 2023, a plebiscite was conducted pursuant to City Ordinance No. 275-2023 to ratify the merging and renaming of various Barangay in the City of Bacoor, Cavite and 90.44% of votes consisted of YES votes;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Sanggunian of Barangay of Barangay Talaba 1, in motion of Kagawad Alvin A. Alcaparaz and duly seconded by Kagawad Melly T. Rana approving the Barangay Ordinance

RESOLVED FURTHER, that this Ordinance shall take effect upon approval.
