Subject: **RESOLUTION NO. 007 - SERIES OF 2024: A RESOLUTION APPROVING THE SANGGUNIANG KABATAAN (SK) OF BARANGAY P.F. ESPIRITU 5 ANNUAL BUDGET FOR CY 2024 AMOUNTING TO SIX HUNDRED THIRTEEN THOUSAND FIFTY-ONE PESOS AND SIXTY CENTAVOS (PHP613,051.60) – PNOA 763-2024 dated November 25, 2024**

Referred to this Committee on the 118<sup>th</sup> Regular Session is the above-subject matter for appropriate action and recommendation.

Section 329 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", provides that, and we quote:

"SECTION 329. Barangay Funds. – Unless otherwise provided in this Title, all the income of the barangay from whatever source shall accrue to its general fund and shall, at the option of the barangay concerned, be kept as trust fund in the custody of the city or municipal treasurer or be deposited in a bank, preferably government-owned, situated in or nearest to its area of jurisdiction. Such funds shall be disbursed in accordance with the provisions of this Title. Ten percent (10%) of the general fund of the barangay shall be set aside for the **sangguniang kabataan**."

While the Sangguniang Kabataan is financially independent in its operations, disbursements, and encashment of its funds, income, and expenditures the Committee adheres to the provisions of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 10742, as amended, and hereunder quoted for ready reference:

"REVISED RULES AND REGULATIONS IMPLEMENTING REPUBLIC ACT (RA) NO. 10742, OTHERWISE KNOWN AS THE "SANGGUNIANG KABATAAN REFORM ACT OF 2015," AS AMENDED BY RA NO. 11768

(d) The appointed SK treasurers shall undergo mandatory bookkeeping training from, and **must be duly certified by the Technical Education and Skills Development Authority (TESDA)** before the assumption of office. Provided that, the mandatory bookkeeping training shall be in addition to the mandatory training under Section 31 of this Rules. Provided further, that only the certification from TESDA shall be considered for purposes of appointment as SK treasurer. Provided finally, that the appointed SK treasurers shall be prioritized in the allocation of appropriate TESDA scholarships in accordance with the guidelines to be issued by the TESDA for the purpose.

SEC. 20. SK Funds. – The SK funds shall be governed by the following provisions:

X X X

(d) The budget cycle of the SK shall be synchronized with that of the barangay. As such, the sangguniang panlungsod or sangguniang bayan shall, within sixty (60) days upon receipt hereof, **review the annual budget and supplemental budget of the SK on their compliance with the immediately preceding provision and other existing laws, rules, and regulations. Noncompliance shall render said budgets inoperative either in whole or in part.** Failure on the part of the sanggunian to complete the review within the prescribed period shall render the said annual budget deemed approved.

Consistent with the afore-cited mandate, and considering that the attached documents to support the proposed Sangguniang Kabataan Annual Budget show that it has been properly examined and reviewed by the concerned City Accounting Office and City Budget Office in compliance with Republic Act No. 7160 and Revised Implementing Rules and Regulations (IRR) of Republic Act No. 10742, as amended, Honorable Rogelio M. Nolasco moved for the approval of the said Sangguniang Kabataan annual budget.

The motion was unanimously seconded by the majority of the Honorable Members of the 5<sup>th</sup> Sangguniang Panlungsod. The Annual Budget for Calendar Year 2024 of Sangguniang Kabataan of **Barangay SAN P.F. ESPIRITU 5**, Bacoor City was **APPROVED**, charge to the approved Annual General Fund of the Barangay for FY 2024.

**RECOMMENDATION:**

In view of the foregoing, the Honorable Members of the Committee hereby recommend **TO APPROVE** the Sangguniang Kabataan Annual Budget for CY2024 of Barangay **P.F. ESPIRITU 5**, Bacoor City in the total amount of **SIX HUNDRED THIRTEEN THOUSAND FIFTY-ONE PESOS AND SIXTY CENTAVOS (PHP613,051.60)**, subject to the existing accounting and auditing rules and regulations.

WHEREAS, the Republic Act 10742, or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter 3 Sec. 3 (a) states that the Sangguniang Kabataan shall approve the annual budget which is the annual step of the Annual Barangay Youth Investment Program before the start of the succeeding fiscal year, and, if the Sangguniang Kabataan funds allow, a supplementary budget;

WHEREAS, the Republic Act 10742, or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter 3 The Kapisanan ng Kabataan and the Sangguniang Kabataan, Section 3 Powers and Functions of the Sangguniang Kabataan, item (c) states that "The Sangguniang Kabataan shall promulgate resolutions necessary to carry out the objectives of the youth in the Barangay in accordance with the Comprehensive Barangay Youth Development Plan and the applicable provisions of the Act."

WHEREAS, the Department of Budget and Management (DBM) – Department of the Interior and Local Government (DILG) – National Youth Commission (NYC) Joint Memorandum Circular (JMC) No. 1, s. 2019, or the Guidelines on the Appropriation, Release, Planning and Execution Process for the SK Funds signed January 23, 2019, under 3.0 General Guidelines, item 3.1 Appropriation of the SK Fund of the Barangay, item 3.1.2 states that "For budget preparation purposes, the barangay treasurer shall inform, in writing, the SK commission and the SK treasurer on or before the 15<sup>th</sup> day of September of the estimated percentage (10%) of the general fund of the barangay for the ensuing fiscal year, supported by a certification of income of the barangay from the municipal treasury."

Espiritu 5 was finalized and approved dated July 29, 2024, by the virtue of SK P.F. Espiritu 5 Resolution No. 005-2024, as endorsed by the Kalipunan ng Kabataan (KK) Members, and ratified by the SK members.

**WHEREAS**, the Department of Budget and Management (DBM) – Department of the Interior and Local Government (DILG) – National Youth Commission (NYC) Joint Memorandum Circular No. 1, s. 2019, of the Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds, under 3.3.2 Budget Preparation by the SK, item 3.3.2.1 states that "The SK Annual Budget, which is the financial plan embodying the estimates of income and expenditures of the SK for one (1) fiscal year, shall be prepared in accordance with the approved ABYIP."

**WHEREAS**, the Department of Budget and Management (DBM) – Department of the Interior and Local Government (DILG) – National Youth Commission (NYC) Joint Memorandum Circular No. 1, s. 2019, or the Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds, under 3.3.4 Budget Review by the Sangguniang Panlungsod or Sangguniang Bayan, item 3.3.4 states that "The sangguniang panlungsod or sangguniang bayan, as the case may be, shall within sixty (60) days upon receipt review the annual/supplemental budget of the SK in compliance with the priority programs, projects, and activities identified under Section 20 (c) of RA No. 10742, and with other existing laws, rules and regulations."

**WHEREAS**, the SK Annual Budget for 2024, after the approval of the Annual Barangay Youth Investment Program (ABYIP) 2024 and the Comprehensive Barangay Youth Development Plan (CBYDP) 2023-2025, needs to be submitted and endorsed to the Sangguniang Panlungsod for its review and approval through the City Budget Office pursuant to the provisions of the DBM – DILG – NYC JMC No. 1, s. 2019.

**WHEREAS**, the Sangguniang Kabataan (SK) of P.F. Espiritu 5 believes in its capacity and capability to enact a resolution that initiates and expedites the approval of its SK Fund, which would be maximized and utilized to facilitate and implement youth development and empowerment programs, projects, and activities in the barangay.






