Subject: P.F. ESPIRITU 5: RESOLUTION NO. 005 SERIES OF 2024: A RESOLUTION APPROVING THE COMPREHENSIVE BARANGAY YOUTH DEVELOPMENT PLAN (CBYDP) 2024-2026 OF THE SANGGUNIANG KABATAAN OF BARANGAY P.F. ESPIRITU 5 ADOPTING AND INTEGRATING THE YOUTH DEVELOPMENT AND EMPOWERMENT PROGRAMS FOR BARANGAY P. F. ESPIRITU 5 YOUTH – PNOA 764-2024 dated November 25, 2024

Referred to the Committee on the 118th Regular Session is the above-subject matter for appropriate action and recommendation.

Memorandum Circular No. 2024-061 was issued by the Department of Interior and Local Government on April 19, 2024 in line with the implementation and operationalization of SK Reform Act of 2015 (RA No. 10742) and consonant with DBM-DILG-NYC Joint Memorandum Circular No. 1, Series of 2019 dated January 23, 2019.

The aforementioned issuances require all the SK Officials, Pederasyon Officers and LYDOs to accomplish the following:

- Comprehensive Barangay Youth Development Plan (CBYDP)
- Annual Barangay Youth Investment Program (ABYIP)
- Local Youth Development Plan of the Pederasyong ng mga SK at all levels

FINDINGS:

The Sangguniang Kabataan Resolution No. 005, Series of 2024, as the basis for the approval of Sangguniang Kabataan annual budget complies with the provisions of Sangguniang Kabataan Reform Act of 2015 and other national issuances for the purpose.

Further, the Committee understood that the SK officials of Barangay P.F. ESPIRITU 5 will strictly observe and comply with the **National Youth Commission (NYC) Resolution No. 28, Ad Referendum Series of 2023**, the **"GUIDELINES ON MONITORING THE IMPLEMENTATION OF THE LOCAL YOUTH DEVELOPMENT (LYDP)"** which applies to all SK officials, Pederasyon Officers and LYDOs.






RECOMMENDATION:

RESOLUTION NO. 005 – SERIES OF 2024

A RESOLUTION APPROVING THE COMPREHENSIVE BARANGAY YOUTH DEVELOPMENT PLAN (CBYDP) 2024-2026 OF THE SANGGUNIANG KABATAAN (SK) OF BARANGAY P.F. ESPIRITU 5 ADOPTING AND INTEGRATING THE YOUTH DEVELOPMENT AND EMPOWERMENT PROGRAMS FOR BARANGAY P.F. ESPIRITU 5 YOUTH

WHEREAS, the Republic Act 10742, or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter 8, The Kalakasan ng Kabataan and the Sangguniang Kabataan Sec. 8 Powers and Functions of the Sangguniang Kabataan, Item (a) states that "The Sangguniang Kabataan shall, in consultation and concurrence of the Kalakasan ng Kabataan, and within three (3) months from assumption to office, formulate a three (3)-year rolling plan which shall be known as the Comprehensive Barangay Youth Development, which shall serve as basis in the preparation of the Annual Barangay Youth Investment Program. This plan shall be aligned with the Philippine Youth Development Plan (PYDP) and other Local Youth Development Plans at every level, municipal, city and provincial as is relevant."

WHEREAS, the Republic Act 10742, or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter 8, The Kalakasan ng Kabataan and the Sangguniang Kabataan Sec. 8 Powers and Functions of the Sangguniang Kabataan, Item (b) states that the Sangguniang Kabataan shall "Approve the annual budget which is the annual slice of the Annual Barangay Youth Investment Program before the start of the succeeding fiscal year, and, if the Sangguniang Kabataan finds allow, a supplemental budget."

WHEREAS, the Republic Act 10742, or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter 8, The Kalakasan ng Kabataan and the Sangguniang Kabataan, Section 8 Powers and Functions of the Sangguniang Kabataan, Item (c) states that "The Sangguniang Kabataan shall promulgate resolutions necessary to carry out the objectives of the youth in the barangay in accordance with the Comprehensive Barangay Youth Development Plan and the applicable provisions of this Act."

WHEREAS, the Implementing Rules and Regulations of Republic Act 10742 or the Sangguniang Kabataan (SK) Reform Act of 2015, under Rule II: The Katiwiran ng Kabataan and the Sangguniang Kabataan, Section 20 SK Funds, item (c) states that "All SK funds shall be allocated in an annual budget, and if the funds allow, in a supplemental budget in accordance with the adopted ABYIP. Both the CBYDP and ABYIP shall give priority to programs, projects and activities that will promote and ensure equitable access to quality education, environmental protection, climate change adaptation, disaster risk reduction and resiliency, youth employment and livelihood, health, including health services and adolescent sexual and reproductive health, anti-drug abuse, gender sensitivity, sports development, and capability building which emphasizes leadership training."

WHEREAS, the Comprehensive Barangay Youth Development Plan (CBYDP) 2024-2026 of the Sangguniang Kabataan (SK) of Barangay P.F. Espiritu 5 shall promote and prioritize the welfare of the barangay youth through the youth development and empowerment-focused programs, projects, and activities (PPAs) integrated in it.

WHEREAS, the Department of Budget and Management (DBM) – Department of the Interior and Local Government (DILG) – National Youth Commission (NYC) Joint Memorandum Circular No. 1, s. 2019, or the Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds signed January 23, 2019, under 3.0 General Guidelines, Item 3.1 Appropriation of the SK Fund by the Barangay, Item 3.3 Planning and Budgeting Process for the SK Fund, Item 3.3.1 Planning Process by the SK, Item 3.3.1.1 states that "The SK, in consultation with the Katiwiran ng Kabataan, shall formulate a 3-year rolling plan, which shall be known as Comprehensive Barangay Youth Development Plan (CBYDP). This plan shall be signed with the Philippine Youth Development Plan and Local Youth Development Plans in provincial, city or municipal level."

WHEREAS, the Department of Budget and Management (DBM) – Department of the Interior and Local Government (DILG) – National Youth Commission (NYC) Joint Memorandum Circular No. 1, s. 2019, or the Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds signed January 23, 2019, under 3.0 General Guidelines, under item 3.1 Appropriation of the SK Fund by the Barangay, Item 3.3 Planning and Budgeting Process for the SK Fund, under item 3.3.1 Planning Process by the SK, Item 3.3.1.2 states that "The CBYDP shall serve as the basis for the preparation of the Annual Barangay Youth Investment Program (ABYIP). The ABYIP shall contain the specific programs, projects, and activities with corresponding project costs, including the necessary fund flows to approximate the reasonable timing in the release of funds. It is understood that the ABYIP shall reflect the total resource requirement for the budget year."

WHEREAS, the Sangguniang Kabataan (SK) of P.F. Espiritu 5 believes in its capacity and capability to enact a resolution that initiates and expedites the approval of its SK Youth Development and Empowerment programs, projects, and activities (PPAs), for the benefit and betterment of the welfare and well-being of the Barangay P.F. Espiritu 5 youth.

WHEREAS, the Sangguniang Kabataan (SK) of P.F. Espiritu 5 will be spearheading the approval of the Comprehensive Barangay Youth Development Plan (CBYDP) for 2024-2026, to capacitate and empower the SK for the facilitation and implementation of the different youth development and empowerment programs, projects, and activities for Barangay P.F. Espiritu 5 youth.
