Referred to this Committee on the 118th Regular Session is the above-subject matter for appropriate action and recommendation.

The Local Disaster Risk Reduction and Management Fund (LDRRMF) can be used for disaster prevention, mitigation, preparedness, response, rehabilitation, and recovery. For its purpose, the use of the fund includes the following:

- Purchasing early warning systems
- Acquiring preparedness equipment
- Buying life-saving rescue equipment, supplies, and medicines
- Training
- Paying premiums for calamity insurance
- Post-disaster activities

During the hearing of the previously approved barangay request of the same nature, the Committee noted the following facts, processes and procedures that were properly established by the City Accountant Office and City Budget Office:

- The unutilized calamity fund is part of the saving, and as a trust fund in the current year. The trust fund can be re-programmed to related projects.
- The request of the Barangay to utilize the calamity fund, as a trust fund, covers the period from the year 2022 to 2023.
- The unutilized risk reduction and management fund within the period of five years, as a trust fund, can be utilized by the barangay as long as there is a **disaster risk reduction plan**, as per the advice of Auditor of the Commission On Audit, Bacoor City and the Head of Bacoor Disaster Risk Reduction and Management Office,
- The submission of a supplemental budget to be processed by the City Budget Office is no longer required considering that it is a trust fund. The subject matter falls under the processing of the City Accounting Office.
- The request of the Barangay to utilize the unexpended fund is a continuing process as long as there is savings based on the record of the City Accounting Office and until the balances of which are expended and the programs are properly documented.
- The Barangay have already submitted the required risk reduction management plan.

RECOMMENDATION:

In view of the foregoing, and considering that the existing law allows the utilization of unexpended Local Risk Reduction and Management Fund covering the current year, the Honorable Members of the Committee hereby recommend **TO APPROVE** the Barangay Resolution No. 31, Series of 2024 of Barangay **TALABA 2**, Bacoor City, involving the amount of **ONE MILLION TWENTY-NINE THOUSAND SIX HUNDRED SEVENTY-SIX PESOS AND SIXTY-FIVE CENTAVOS (PHP1,029,676.65)**, subject to the existing laws and DBM/DILG circulars and issuances.








WHEREAS, the Barangay Disaster Risk Reduction and Management Committee
(BDRMC) convened last **OCTOBER 31, 2024** to purchase **ONE (1) UNIT** of
ambulance vehicle funded from the **UNEXPENDED BALANCES** from year 2021-2023,
for reason that the only existing unit being utilized is not enough to cater patients in
transporting patients to hospital, and always encountering mechanical troubles/
problems.

WHEREAS, on 30 October 2024, the Barangay Development Council (BDC)
passed Resolution No. 06, series of 2024 entitled: **"A RESOLUTION ADOPTING THE
FIVE (5) YEAR PLAN OF BARANGAY DISASTER RISK REDUCTION AND
MANAGEMENT COMMITTEE ON THE UTILIZATION OF THE UNEXPENDED
BALANCES OF THE YEAR 2021-2023 BARANGAY DISASTER RISK REDUCTION
MANAGEMENT FUND"**.

WHEREAS, the Barangay Development Council is considering that the
existing vehicle is not enough in rescuing and unserviceable beyond repair, and
Barangay Talaba 2 is preparing for contingency plan to cater patients and vulnerable
sectors in transporting them to hospitals and evacuation centers.

WHEREAS, the clamored of constituents to Punong Barangay, to have an additional ambulance was highly recommended to the assembled body, and its proper and fitting for additional ambulance be granted.

NOWHEREFORE, upon the motion of Kagawad Juanito E. Llesis, chair on committee on health, duly seconded by Mr. Edgardo L. Torrijos, President of Senior Citizens and all the Councils present be it;

RESOLVED, as it is hereby **RESOLVED** to utilize the unexpended balances in purchasing one (1) unit of ambulance vehicle of Barangay Talaba 2, City of Bacoor, Cavite.

RESOLVED FURTHER that copies of this Resolution be furnished and delivered to BDRMO and Sangguniang Panglungsod and to any other concerned agencies.


