Subject: MAMBOG 3: **RESOLUTION NO. 15 - SERIES OF 2024 ENTITLED: A RESOLUTION ADOPTING THE PROGRAM, PROJECTS, ACTIVITIES (PPAs), AND APPROVING THE BARANGAY DISASTER RISK REDUCTION AND MANAGEMENT INVESTMENT PLAN MAMBOG 3 FOR CALENDAR YEAR 2024.** – PNOA 779-2024 dated November 25, 2024

Referred to this Committee during the 118th Regular Session is the above-subject matter for appropriate action and recommendation.

The Barangay Disaster Risk Reduction and Management Plan will be an important tool for managing potential disaster, demonstrate commitment toward safety within the community, identifies potential hazards and risks in the area, possible steps to mitigate the risks and the strategies to enact should a hazard impact and cause a disaster.

LEGAL BASIS:

The NDRRMC-DBM-DILG Joint Memorandum Circular (JMC) No. 2013-1 dated March 25, 2013 provides that, and we quote "Section 21 of RA No. 10121, the LDRRMF amounting to not less than five percent (5%) of the estimated revenue from regular sources shall be set aside to support disaster risk management activities such as, but not limited to the pre-disaster preparedness programs including training, purchase of disaster response and rescue equipment, supplies and medicines, for post-disaster activities, and payment of premiums on calamity insurance.

Of the amount appropriated for LDRRMF, thirty percent (30%) shall be allocated as a lump sum Quick Response Fund (QRF) or stand-by fund for relief and recovery programs in order that situation and living conditions of people in communities or areas stricken by disasters, calamities, epidemics or complex emergencies, may be normalized as quickly as possible."

RECOMMENDATION:

In view of the foregoing, and considering that the existing law mandates the disaster preparedness plan and the allocation of funds for the purpose, the Honorable Members of the Committee hereby recommend **TO APPROVE** the **Barangay Resolution**
