Subject: POBLACION REQUEST FOR APPROVAL OF BARANGAY RESOLUTION NO. 19 SERIES OF 2024 FROM BARANGAY POBLACION ENTITLED: A RESOLUTION AUTHORIZING THE UTILIZATION OF THE UNUTILIZED AMOUNT OF PHP120,000.00 FROM THE 70% CALAMITY FUND OF BARANGAY POBLACION FOR THE PROCUREMENT OF DISASTER RISK REDUCTION AND MANAGEMENT (DRRM) SUPPLIES, EQUIPMENT AND MATERIALS – PNOA 796-2024 dated December 2, 2024

Referred to this Committee on the 119th Regular Session is the above-subject matter for appropriate action and recommendation.

The Local Disaster Risk Reduction and Management Fund (LDRRMF) can be used for disaster prevention, mitigation, preparedness, response, rehabilitation, and recovery. In these purpose, the use of the fund includes the following:

- Purchasing early warning systems
- Acquiring preparedness equipment
- Buying life-saving rescue equipment, supplies, and medicines
- Training
- Paying premiums for calamity insurance
- Post-disaster activities

During the hearing of the previously approved barangay request of the same nature, the Committee noted the following facts, processes and procedures that were properly established by the City Accountant Office and City Budget Office:

- The unutilized calamity fund is a part of the saving and as a trust fund in the current year. The trust fund can be re-programmed to related projects.
- The request of the Barangay to utilize the calamity fund, as a trust fund, covers the period from the year 2022 to 2023.
- The unutilized risk reduction and management fund within the period of five years, as a trust fund, can be utilized by the barangay as long as there is a **disaster risk reduction plan**, as per the advice of Auditor of the Commission On Audit, Bacoor City and the Head of Bacoor Disaster Risk Reduction and Management Office,
- The submission of a supplemental budget to be processed by the City Budget Office **is no longer required** considering that it is a trust fund. The subject matter and its processing falls under the responsibility of City Accounting Office.
- The request of the Barangay to utilize the unexpended fund is a continuing process as long as there is savings based on the record of the City Accounting Office and until the balances of which are expended and the programs are properly documented.
- The Barangay have already submitted the required risk reduction management plan.

RECOMMENDATION:

In view of the foregoing, and considering that the existing law allows the utilization of unexpended Local Risk Reduction and Management Fund covering the current year, the Honorable Members of the Committee hereby recommend **TO APPROVE** the Barangay Resolution No. 19, Series of 2024 of Barangay **POBLACION**, Bacoor City, involving the amount of **ONE HUNDRED TWENTY THOUSAND PESOS (PHP120,000.00)**, subject to the existing laws and DBM/DILG circulars and issuances.

A RESOLUTION AUTHORIZING THE UTILIZATION OF THE UNUTILIZED AMOUNT OF PHP 120,000.00 FROM THE 70% CALAMITY FUND OF BARANGAY POBLACION FOR THE PROCUREMENT OF DISASTER RISK REDUCTION AND MANAGEMENT (DRMM) SUPPLIES, EQUIPMENTS, AND MATERIALS

WHEREAS, Republic Act No. 10721, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010," mandates all local government units, including barangays, allocate a portion of their budget for disaster risk reduction and management activities, including preparedness, mitigation, response, and rehabilitation.

WHEREAS, in order to maintain the peace and order situation effectively, it is necessary to have numerous Barangay Police Officers to man the jurisdiction of Barangay Poblacion;

WHEREAS, Barangay Poblacion has an unutilized balance of one hundred twenty thousand pesos, (PHP 120,000.00) from its 70% Calamity Fund

WHEREAS, the Sangguniang Barangay recognizes the need to purchase Disaster Risk Reduction and Management (DRMM) supplies, equipment, and materials to enhance the barangay's preparedness and capacity to respond to natural and human-induced calamities;

WHEREAS, the procurement of these supplies and equipment is crucial to ensuring the safety and protection of the residents of Barangay Poblacion during disaster and emergencies, and is an allowable expense under the calamity fund;
