

The ordinance lacks specific provisions on penalties, which are essential to ensure enforceability and compliance. As stated in the title, the ordinance is expected to include a section clearly stipulating penalties and sanctions for violations of the provisions. The absence of such provisions renders the ordinance incomplete and non-implementable in its current form.



ORDINANCE No. 001B-2024

AN ORDINANCE MANDATING THE SEGREGATION AT SOURCE OF ALL HOUSEHOLD INSTITUTIONAL, AGRICULTURAL AND COMMERCIAL WASTE INTO WET BIODEGRADABLE AND DRY OR NON-BIODEGRADABLE WASTE, REQUIRING THE PROPER DISPOSAL OF SOLID WASTES AND PROVIDING PENALTIES HEREOF

WHEREAS, Section 10 Republic Act No. 9003 (Also known as the Ecological Solid Waste Management Act of 2000) provides that the LGU's shall be primarily responsible for the implementation and enforcement of the provisions of this Act within their respective jurisdictions. Segregations and collection of solid wastes shall be conducted in Barangay level specifically for biodegradable, compostable and reusable waste; provided that the collection of non-recyclable materials and special wastes shall be the responsibility of the city."

WHEREAS, Section 21 of R.A. 9003 further provides that "LGU's shall evaluate alternative roles for the private and public sectors in providing collection services, type of collection system, or combination of systems, that best meet their needs; Provided that the segregation of wastes shall be primarily conducted at source to include household, institutional, agricultural and commercial sources.

WHEREAS, the growing population of the Barangay now producing more solid waste than ever before necessitating the immediate and mandatory segregation of waste from its source as to promote public health and general welfare.

NOW THEREFORE, upon motion of Kagawad Dennis D. Verde, unanimously approved all the Sangguniang Barangay members present, BE IT ORDAINED AS IT HERBY OBTAINED by the Sangguniang Barangay in regular session assembled.
