**Subject: FROM BARANGAY POBLACION: ORDINANCE 04-2025 ENTITLED: "AN ORDINANCE REGULATING DOG OWNERSHIP AND CONTROL IN BARANGAY POBLACION". (PNOA-853-2025 dated February 24, 2025)**

Barangay Poblacion has submitted *Ordinance No. 04-2025*, which aims to regulate dog ownership and control within the barangay. The ordinance seeks to address concerns related to responsible pet ownership, stray animals, public safety, and sanitation.

**FINDINGS:**

The key points in implementing this ordinance were:

**1. Public Safety and Health Protection:**

- Stray dogs are dangerous as they can transmit rabies, attack people and cause road accidents. The ordinance imposes measures to avoid such occurrences, guaranteeing the safety of the inhabitants.
- Requiring pet vaccinations aligns with national and local government efforts to eliminate rabies and other animal-borne diseases.

**2. Compliance with National and Local Laws:**

- The ordinance conforms to Republic Act No. 9482 (Anti-Rabies Act of 2007), which seeks responsible pet ownership, vaccination, and control over stray animals.
- It complements the existing programs of the Bacoor City Government on public safety and animal welfare.

**3. Environmental and Sanitation Improvement:**

- Loose or unrestrained dogs contribute to waste problems and public disturbances. The ordinance enforces pet waste disposal regulations, keeping public spaces clean and sanitary.

**4. Community Welfare and Orderliness:**

### AN ORDINANCE REGULATING DOG OWNERSHIP AND CONTROL IN BARANGAY POBLACION

#### SECTION 1. TITLE

#### SECTION 2. KAHULUGAN

Ang ordinansang ito ay magkakabisa sa loob ng 30 araw mula sa pag-apruba nito. Dog Ownership and Control Ordinance."


