Subject: **FROM BARANGAY DULONG BAYAN: RESOLUTION NO. 003-2025 ENTITLED "A RESOLUTION IMPLEMENTING A SEGREGATED WASTE COLLECTION SYSTEM IN BARANGAY DULONG BAYAN.." (PNOA-886-2025 dated April 14, 2025)**

Barangay Dulong Bayan has submitted Resolution No. 003-2025, titled "A Resolution Implementing a Segregated Waste Collection System in Barangay Dulong Bayan." The proposed resolution seeks to institutionalize a barangay-level system of segregated waste collection to promote environmental sustainability, improve waste management practices, and ensure public health and cleanliness within the community.

**FINDINGS:**

The key points in implementing this resolution were:

1. The Barangay Council of Dulong Bayan recognizes the need to implement a comprehensive solid waste management system that promotes environmental sustainability and adheres to the principles of the Ecological Solid Waste Management Act (RA 9003).
2. The responsibility of the barangay to effectively and efficiently implement the solid Waste Management System under Republic Act 9003 in its territorial jurisdictions.
3. The unsystematic waste disposal by households, commercial industry/establishments cause unsightly surroundings and spread of communicable diseases.
4. The practice of waste segregation to facilitate reuse and recycling does not only reduce the cost of collection and disposal of garbage but conserves the natural resources of materials and avoid wasteful consumption of goods.

This implementation of a segregated waste collection system is both timely and necessary for achieving a cleaner, greener, and healthier community.

- Section 1:  
Residents shall segregate their waste at the source into the following categories: biodegradable, recyclable, and residual.
- Section 2:  
Each household shall be provided with designated, clearly labeled waste bins for each waste category.
- Section 3:  
The Barangay Ecological Solid Waste Management Committee (BESWMC) shall establish a schedule for the collection of segregated waste.
- Section 4:  
A "no segregation, no collection" policy shall be strictly enforced.

**NOW, THEREFORE, BE IT RESOLVED** that the Sangguniang Barangay of Dulong Bayan hereby adopts and approved a resolution to implement a mandatory segregated waste collection system within the barangay.




