Subject: FROM BARANGAY DULONG BAYAN: RESOLUTION NO. 05 SERIES OF 2025 ENTITLED "A RESOLUTION REQUESTING S.C LACSON PETROLEUM FILLING STATION ALSO KNOWN AS TOTAL GASOLINE STATION, FOR AN AGREEMENT BETWEEN THE SANGGUNIANG BARANGAY OF DULONG BAYAN REGARDING GASOLINE AND LUBRICANTS." (PNOA-888-2025 dated April 14, 2025)

Barangay Dulong Bayan has submitted *Resolution No. 05, Series of 2025*, which seeks approval for entering into an agreement with S.C. Lacson Petroleum Filling Station, also known as TOTAL Gasoline Station, for the provision of gasoline and lubricants necessary for the official vehicles and equipment used in barangay operations.

FINDINGS:

The key points in implementing this resolution were:

1. The LGU Bacoor mandates the Barangay to enforce policies and guidelines regarding the gasoline and lubricants reimbursement.
2. The involvement of the private sector is deemed essential and advisable to promote efficient and extensive system.
3. The SC Lacson Petroleum Filling Station represented by its owner/operator Ms. Sallie C. Lacson located at Sinbanali, Bacoor City, Cavite.
4. The mode of payment for the gasoline and lubricants needed must be checked issued by the Sangguniang barangay of Dulong Bayan and named after the S.C Lacson Petroleum Filling Station.

This Filling Station is essential for the sustained and efficient delivery of public services and the proper management of barangay operations.
