

Subject: REQUEST FOR APPROVAL OF RESOLUTION FROM BARANGAY P.F. ESPIRITU 5: SANGGUNIANG BARANGAY RESOLUTION NO. 02 Series of 2025 ENTITLED: "A RESOLUTION PROHIBITING THE CONSTRUCTION OF A GASOLINE STATION IN BARNANGAY P.F. ESPIRITU 5, CITY OF BACOOR, CAVITE. (PNOA 926-2025 dated 19 May 2025)

Acting on the proposed resolution requesting the approval of Barangay P.F. Espiritu 5 Resolution No. 02, Series of 2025, during the 140th Regular Session on 19 May 2025. Hon. Alde Joselito F. Pagulayan reports the following:

#### FINDINGS:

After a careful review of the Barangay Resolution and consideration of community concerns, the Committee finds the following:

The construction of a gasoline station in the proposed area is expected to worsen traffic congestion due to increased vehicular activity in an already busy zone.

The establishment of a gasoline station raises environmental concerns such as the possibility of oil leaks, fuel spills, and groundwater contamination, which pose serious longterm threats to public health and natural resources.

The Barangay Council has received multiple complaints from local residents citing the anticipated noise pollution and disruption to daily life resulting from the operation of a gasoline station.

The proposed site is located near densely populated residential zones and commercial buildings. The inherent risks associated with flammable materials, especially in the event of a fire, present a grave danger to nearby communities.

The odor and vapors emitted during fuel deliveries and daily operations are expected to permeate the surrounding residential area. This poses a significant health hazard, particularly to vulnerable groups such as children, senior citizens, and individuals with pre-existing health conditions.

IN BARANGAY P.F. ESPIRITU S, CITY OF BACOOR, CAVITE DUE TO THE DANGERS IT POSE TO THE
HEALTH AND SAFETY OF BARANGAY RESIDENTS.

WHEREAS, the Sangguniang Barangay has received numerous applications from the private sector for the construction of gasoline stations within the territorial jurisdiction of Barangay P.F. Espiritu S.

WHEREAS, the construction of any gasoline station in the barangay in addition to those already existing and operating will significantly increase traffic congestion in the area.

WHEREAS, the construction of a gasoline station poses potential environmental hazards, including the risk of oil spills and groundwater contamination.

WHEREAS, the Barangay Council received numerous complaints from residents regarding the potential noise pollution and inconvenience that may be caused by any additional gasoline station that will be allowed to operate within the barangay.

WHEREAS, the construction of more gasoline stations within the barangay will not only lead to traffic congestion but will also increase the likelihood of fire incidents and will expose residents to pollution coming from fuel fumes and motor vehicles that that will patronize the said establishments.
