**SUBJECT: *PCO-2026-074 – AN ORDINANCE FURTHER AMENDING SECTION 3 OF CITY ORDINANCE NO. 319-2023 AND SECTION 1 OF CITY ORDINANCE NO. CO 29-2019 IN RELATION TO CITY ORDINANCE NO. CO 24-2014 SERIES OF 2014, ALSO KNOWN AS 'ORDINANCE GRANTING A FREE MOVIE PRIVILEGE TO ALL BACOOR SENIOR AND DISABLED CITIZENS 2014. (PCO-2026-074 dated January 27, 2026)***

The above-mentioned ordinance underwent its first reading on January 26, 2026 during the 27th Regular Session of the Sangguniang Panlungsod. The said ordinance was referred by the Presiding Officer, Hon. City Vice Mayor Rowena Bautista Mendiola to the Committee on Senior Citizen.

The Committee on Senior Citizen sent out invitations to the resource persons conducted a committee hearing on January 29, 2026 at the Session Hall of the Sangguniang Panlungsod at 11:00 o'clock in the morning.

**FINDINGS:**

On January 22, 2026, the Office of the Panlungsod received a letter from the Office of the Mayor on the above subject matter. The Ordinance is a social service legislation designed to promote the welfare and enjoyment of Senior Citizens (SC) and Persons with Disabilities. This Ordinance shall only apply to all cinema operators and establishments within the City of Bacoor and may only be availed of once a day every Monday by the Senior Citizens and Persons with Disabilities who are bona fide residents of the City of Bacoor, Province of Cavite, as evidenced by the Electronic Special Bacoor Residents (E-SBR) Card issued by the City Government of Bacoor.

**RECOMMENDATION:**

The Free Movie Privilege may be extended to various classes or group of individuals who are bona fide residents of the City of Bacoor in celebration or commemoration of any national or local events, subject to the availability of funds as determined and approved by the Parties. Special beneficiaries, excluding Senior Citizens and Person with Disabilities, are entitled to this privilege only once per year upon presentation of their respective (E-SBR) Card. The City Mayor has the exclusive right to identify the Special Beneficiaries who are entitled to the benefits of this Ordinance. The City Government of Bacoor, through the City Mayor, may include more events if funds are available.

The Committee respectfully recommends to PASS and APPROVE of the said City Ordinance.







