The aforementioned proposed city ordinance was requested for enactment by the Office of the City Mayor last January 29, 2026.

FINDINGS :

The draft ordinance is yet to be available for review and assessment by the committee. Hence, no committee hearings were conducted regarding the abovementioned proposed ordinance.

To date, the committee hasn't received any draft ordinance crucial for administering future committee hearings on the subject matter.

RECOMMENDATION :

Following careful analysis and deliberation, the Chairperson for the Committee on Information and Communications Technology, Hon. Adrielito G. Gawaran recommends to **temporarily archive** the proposed ordinance until such time that the draft ordinance is available.
