**Subject: AN ORDINANCE AUTHORIZING THE GRANT OF SCHOLARSHIPS AND CASH GRANTS TO VARIOUS STUDENTS RESIDING IN THE CITY OF BACOR, CAVITE WHO ATTAINED EXEMPLARY EDUCATIONAL HONORS, WHO HAVE BROUGHT PRESTIGE TO THE CITY AND TO THE PHILIPPINES IN NATIONAL OR INTERNATIONAL COMPETITIONS, OR WHO TOPPED PROFESSIONAL LICENSURE OR BAR EXAMINATIONS (PCO 2026-080 referred February 16, 2026)**

This Proposed Ordinance was referred to this Committee during the 30<sup>th</sup> Regular Session held on February 16, 2026. The Committee on Youth and Sports Development together with the Committee on Finance and Budget Appropriations conducted a Joint committee hearing on February 24, 2026. During the review and deliberation of the proposed ordinance, the committee unanimously supported the said ordinance which is in line with the state's constitutional obligation to promote high-quality education and to inspire the youth to actively strive for excellence. The enactment of this ordinance represents a meaningful investment in the youth of Bacoor. By fostering a culture of academic distinction, perseverance, and civic pride, it empowers the next generation to become responsible citizens and future leaders. This initiative not only strengthens educational values but also nurtures character, resilience, and a deep sense of community belonging."

- All qualified beneficiaries of the Program shall be given incentives to be taken from the available funds of the City Government of Bacoor and awarded on any date chosen by City Mayor base on the official schedule of activities of the City Government.
- A creation of the Bacoor Excellence Incentive Program will recognize the academic, sports, cultural, literary and artistic achievements of all bonafide residents of the City of Bacoor (BEI Program). The achievements shall include winning in national or international competitions, acquiring Latin Honors upon graduations, or entering the Top Ten of all Professional Licensure or Bar Examinations.
- Beneficiaries who won multiple achievements are qualified to receive more than one type of incentive, but shall not be precluded from receiving the same.
- Cash incentives to be taken from the available funds of the City Government.
