Subject: AN ORDINANCE ESTABLISHING THE BACOR PRIVATE MOTOR POOLING PROGRAM, CREATING THE CITY MOTOR POOLING OFFICE, REGULATING PRIVATE CARPOOLING ACTIVITIES, PROVIDING GUIDELINES FOR SAFE, ORGANIZED AND NON-COMMERCIAL RIDE SHARING, AND REQUIRING MANDATORY INSURANCE COVERAGE FOR PARTICIPANTS WITHIN THE CITY OF BACOR. Referred to the Joint Committee on the 34th Regular Session of 6th Sangguniang Panlungsod the above-subject matter for appropriate action and recommendation.

INFORMATION:

To address the soaring costs of diesel and gasoline, the City Government of Bacoor as of March 16, 2026 have actively finalizing the carpooling ordinance to at least minimize the impact of the high cost of fuel affecting the Bacooreños, to reduce the number of private vehicles on the road and to maximize the use of existing private vehicles while protecting commuters from illegal "colorum" operations.
