Subject: **BARANGAY ORDINANCE NO. 09-2025, SERIES OF 2025 ENTITLED: "AN ORDINANCE DECLARING NO PARKING ZONE IN THE FOLLOWING STREETS AS MAIN ROADS AND STRICT IMPLEMENTATION OF ONE-WAY TO THE SCHOOL ZONE SUCH AS EMERALD STREET AND MERCURY STREET DURING WEEKDAYS OR SCHOOL HOURS TO ENSURE THE SAFETY OF STUDENTS AND REDUCE TRAFFIC. PCR 259-2025** dated November 17, 2025, 2025

Referred to the Joint Committee on the 20th Regular Session of 6th Sangguniang Panlungsod the above-subject matter for appropriate action and recommendation.

INFORMATION:

Barangay Ordinance No. 09-2025 of Barangay Salinas 2, Bacoor City, intends to declare "one way traffic" and "No Parking and Clamping Zone from 8:00am and 5:00pm to 8:00pm", and further request to engage the assistance of CICU in the implementation and enforcement of the ordinance sought to be approved on the following affected streets or main roads in the barangay, as follows: 1) Hawaii Street to Sienna Villas Subdivision, 2) Pisces Street to Guerrero Street to Saturn Street (main road), and 3) Mercury Street to Daang Kalabaw Road exiting to Salinas 1 Road or exiting Aguinaldo Highway.

FINDINGS:

During the Joint Committee hearing held on January 7, 2026, the Joint Committee require the Barangay to conduct public hearing and revise the ordinance to make it consistent with the proper form.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommend **TO TEMPORARY ARCHIVE** the request for approval of Barangay Ordinance No. 09-2025 of Barangay Salinas 2, Bacoor City, Cavite, without prejudice to the filing of the revised ordinance pertaining to the same barangay traffic measure.
