Subject: BARANGAY ORDINANCE NO. 3, SERIES OF 2025 ENTITLED: "AN ORDINANCE REQUIRING COMPANIES ENGAGED IN THE INSTALLATION OF CABLE WIRES, INTERNET SERVICES, AND RELATED WIRE INSTALLATION ACTIVITIES TO SECURE A BARANGAY WORKING CLEARANCE AND PAY THE ASSOCIATED FEE IN BARANGAY NIOG, CITY OF BACOOR, CAVITE" - PCR 322-2025 dated December 15, 2026

Referred to the Joint Committee on the 23rd Regular Session of the 6th Sangguniang Panlungsod is the above-subject matter for appropriate action and recommendation.

The **Local Government Code of 1991 (RA 7160)** authorized the Barangays to levy specific **taxes, fees, and charges**, which accrue exclusively to them. These sources of income are established through a Barangay Ordinance enacted by the *Sangguniang Barangay*, specifically as follows:

- Service fees or charges for the use of barangay property or facilities;
- **Barangay clearance fees;**
- Fees or charges for the commercial breeding of fighting cocks and on cockpits and cockfights;
- Fees or charges on places of recreation with admission fees;
- Fees or charges for billboards, sign boards, neon signs and other outdoor advertisements;
- Toll fees or charges for the use of any public road, pier or wharf, waterway, bridge, ferry, or telecommunications system funded and constructed by the barangay;

- Revenues from the operation of public utilities and barangay enterprises (markets, slaughterhouses, etc.);
- Fines (not exceeding P1,000) for the violation of barangay ordinances; and,
- Proceeds from the sale or lease of barangay property or from loans and grants secured by the barangay government

The two (2) barangay ordinances were jointly heard in a Joint Committee hearing conducted on January 15, 2026.

FINDINGS:

1. The intention and objective of the barangay ordinance is the same with that of PCR 321-2025, as per the explanations of the barangay officials.
2. The amount of fee appears to be excessive, and the imposition of the fee per worker collectively with the company could violate the existing law.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommend **TO RETURN** to sender Barangay Niog, Bacoor City the proposed barangay ordinance for proper review of the amount of fee, revision and consolidation into a single ordinance with **Barangay Ordinance No. 2**, and to make specific as to whom the clearance fee should be imposed.







