Subject: *A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DHSUD) REGARDING THE TRANSFER OF OWNERSHIP OF PREFABRICATED HOMES TO THE CITY GOVERNMENT. (PCR 346-2025 dated January 12, 2026).*

The above-mentioned proposed resolution underwent its first reading on January 12, 2026 during the 25th Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, Acting City Vice Mayor Hon. Catherine Sarino-Evaristo to the Committee on Housing, Land Utilization and Urban Development and Committee on Rules, Privileges, Laws, And Ordinances as sub-committee.

FINDINGS:

A letter from the Office of the City Mayor, requesting for the passage of a Sangguniang Panlungsod resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement on behalf of the City Government of Bacoor with the Department of Human Settlements and Urban Development (DHSUD) regarding the transfer of ownership of Prefabricated Homes to the City Government.

The Memorandum of Agreement covers the transfer of ownership of prefabricated modular housing units to be utilized as temporary resettlement or relocation shelters for individuals and families displaced by fire incidents, calamities, and other emergencies.




