Subject: *A RESOLUTION AMENDING RESOLUTION NO. 2025-646 ENTITLED: "A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO CAUSE THE SALE OR DISPOSITION OF THE PARCELS OF LAND OWNED BY THE CITY GOVERNMENT LOCATED IN BARANGAY SALINAS AND BARANGAY DULONG BAYAN, BACOOR CITY, CAVITE BY WAY OF PUBLIC AUCTION OR BIDDING AS PROVIDED FOR UNDER THE PERTINENT LAWS, ORDINANCES AND ISSUANCES IN CONFORMITY WITH EXISTING AUDITING AND ACCOUNTING RULES AND REGULATIONS". FINDINGS:

After careful evaluation of the documents and deliberation during the Committee's review, the following findings are hereby presented:





- The attachment to Proposed City Resolution No. 348-2026 was duly presented, reviewed, and noted by the Committee;
- The amount subject of the proposed resolution is not reflected in the previous resolution; and
- There is no necessity for an amendment to the previous resolution, as there is no inconsistency or conflict with the proposed measure.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommends the removal from the agenda of the Proposed City Resolution Amending Resolution No. 2025-646 ENTITLED: "A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. 
