**Subject: A resolution amending Resolution No. 2025-837 Entitled: "A Resolution Authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement with SM Prime Holdings, Inc. on behalf of the City Government of Bacoor pertaining to the renewal of the 'Libreng Sakay' Program"**

*(Date referred: February 02, 2026)*

The above-mentioned proposed resolution underwent its first reading on February 02, 2026 during the 28<sup>th</sup> Regular Session of the 6<sup>th</sup> Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

The Committee on Rules and Privileges, Laws and Ordinances sent out invitations to the resource persons and conducted a committee hearing on March 05, 2026 at the Session Hall of the Sangguniang Panlungsod.

After due consultation and deliberation hereby report back to this August Body the findings, information gathered, and recommendation on the above-subject matter. Attached hereto are the attendance sheet and photos taken during the said hearing.

**FINDINGS:**

A letter from the Office of the City Mayor dated January 21, 2026 was received by the Sangguniang Panlungsod requesting the latter to amend the City Resolution No. 2025-837 Series of 2025 regarding the renewal of the Memorandum



of Agreement (MOA) between the City Government of Bacoor and SM Prime Holdings, Inc. pertaining to the Libreng Sakay Program.

This program provides free transportation to underserved communities, reducing residents' daily costs, improving access to education, healthcare, and jobs, promoting environmental sustainability, advancing social equity for low-income individuals, and supporting inclusive mobility goals aligned with the City's development agenda.

The proposed amendment shall extend coverage to 2024 until 2026 to align with the revised Memorandum of Agreement endorsed to the Sangguniang Panlungsod by the Office of the City Mayor.

By the motion of Hon. Reynaldo C. Palabrica duly seconded by all the members of the Sangguniang Panlungsod, the above subject matter was **APPROVED** during its 33<sup>rd</sup> Regular Session.
