**Subject: A LETTER OF COMPLAINT FROM MR. ROLANDO IGNACIO, JR. ET.AL., BARANGAY COUNCILORS OF BARANGAY MALIKSI 2, BACOOR CITY AGAINST PUNONG BARANGAY LIBERATO DIZON AS REGARDS THE ALLEGED PRESENCE OF MANY GHOST EMPLOYEES IN THEIR BARANGAY AND THE ALLEGED SIGNIFICANT REDUCTION OF THEIR HONORARIA. (PCR 357-2026 dated 02 February 2026).**

The said complaint was referred to this Committee by the Presiding Officer, Hon. Rowena Bautista Mendiola, during the 28<sup>th</sup> Regular Session of the 6<sup>th</sup> Sangguniang Panlungsod on February 02, 2026 for appropriate action.

Upon review of the complaint and its supporting documents, it was discovered that the said document is unverified in violation of Rule 4, Section 1 of City Ordinance No. 2024-467 (the "2024 Rules on Barangay Administrative Cases") which provides that "any aggrieved person may file a verified complaint personally or through a representative with the Sangguniang Panlungsod of the City of Bacoor, Cavite personally." The same ordinance defines a verified complaint as one that is duly notarized.

**RECOMMENDATION:**

In view thereof, the Committee respectfully recommends to disregard the said complaint since it did not conform with the prescribed form and to remove the said subject matter from the Council's next order of business.


