Subject: *(PCR 360-2026) AN ORDINANCE PROHIBITING OPEN BURNING OF GARBAGE AND OTHER WASTE MATERIALS WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY POBLACION, IN THE INTEREST OF PUBLIC HEALTH, SAFETY AND ENVIRONMENTAL PROTECTION, AND PROVIDING PENALTIES THEREFOR (Date referred February 2, 2026).*

FINDINGS:

Republic Act 9003 (Ecological Solid Waste Management Act), which prohibits burning discarded household, commercial, and agricultural waste. The City of Bacoor enforces, emphasizing segregation and strict disposal, with Barangay Officials and the Solid Waste Management Board overseeing compliance. Under Chapter 6-Penal Provisions Section 48-3 of Prohibited Acts.

Open burning of garbage and other waste products puts the neighborhood at danger for fire, health problems, and air pollution. Under R.A. 8749 also known Phil. Clean Air Act of 1999, incineration and other form of open burning is prohibited and it can emit toxic and hazardous fumes.

For the purposes of this ordinance, burning solid waste products in public or private open spaces, such as trash, dried leaves, plastic, rubber, paper, fabric, wood, and similar materials, is described.

Penalties for violating this Barangay Ordinance are as follow:

First Offense	Verbal warning and mandatory community service.
Second Offense	Php 500.00 or community service
Third Offense	Php. 1000.00 and/or filing of appropriate complaint under applicable laws.

The role of enforcing this barangay ordinance and issuing citations to violators belongs to the Barangay Tanod and other fully authorized barangay officials.









