Subject: (FROM BARANGAY POBLACION) BARANGAY ORDINANCE NO. 03-2026 ENTITLED: "AN ORDINANCE PROVIDING FOR THE CLEARING OF ROADS AND SIDEWALKS IN BARANGAY POBLACION. PCR 362-206 dated February 2, 2026

Referred to this Committee on the 28th Regular Session of 6th Sangguniang Panlungsod the above-subject matter for appropriate action and recommendation.

INFORMATION:

The barangay ordinance was enacted by the Barangay Poblacion, Bacoor City in compliance with the Department of Interior and Local Government Memorandum Circular No. 2024-053 issued on April 16, 2024, which mandates the **Nationwide Implementation of the Barangay Road Clearing Operations (BaRCO), Assessment, Validation, and Recognition under the Bagong Pilipinas Program**, and requiring all barangays to clear public roads, sidewalks, and alleys of obstructions to improve public safety, traffic flow, and accessibility.

FINDINGS:

1. The Barangay have already conducted a public hearing as required under the Local Government Code.
2. The Bacoor Traffic Management Department and Bacoor Public Safety Department manifested no objection on the provisions of the barangay ordinance, and the issue on overlapping functions were properly resolved
3. The Committee advised the Barangay to revise the ordinance and to incorporate the issuance of receipt on fines and the safekeeping of materials confiscated.





RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Committee hereby recommend **TO APPROVE** the Barangay Ordinance No. 03-2026 entitled "AN ORDINANCE PROVIDING FOR THE CLEARING OF ROADS AND SIDEWALKS IN BARANGAY POBLACION," a compliance of Barangay Poblacion, Bacoor City to Department of Interior and Local Government Memorandum Circular No. 2024-053 issued on April 16, 2024.
