- On 29, January 2026, the Office of the Mayor sent a letter to Sangguniang Panlungsod requesting to pass a resolution authorizing the City Mayor to sign a Memorandum of Agreement (MOA) on behalf of the City Government of Bacoor with Scout Royale Brotherhood Bacoor City Council.
