

The 28th Regular Session of the 6th Sangguniang Panlungsod was held last February 02, 2026. Presiding Officer, City Vice Mayor Rowena Bautista – Mendiola called to order at exactly 10:00 am. Atty. Khalid Atega Jr., Sangguniang Panlungsod Secretary, proceeded with the roll call, the approval of the journal and minutes from the previous regular session, and the reading of the referrals to committees of proposed ordinances, resolutions, messages, communications, petitions, and memorials.

Atty. Atega narrated the aforementioned subject matter with an item number L.3. The Chairperson of the Committee on Information and Communications Technology, Hon. Adrielito G. Gawaran, proposed to PASS the resolution mentioning the agreement between the parties allows for contactless execution of various programs by the City Government of Bacoor, making it easier to handle documentation and granting processes in providing financial assistance, livelihood grants, and other social services.

The Chairman moved for the approval of the stated proposed city resolution. The motion was unanimously seconded by the rest of the city council members and was declared APPROVED by the Chair.

The aforementioned proposed city resolution was endorsed by the Office of the City Mayor to the Sangguniang Panlungsod on January 30, 2026. The draft Tripartite Memorandum of Agreement and draft Confidentiality and Non-Disclosure Agreement were subsequently attached together with the draft Memorandum of Agreement between the City Government of Bacoor and Neo-Connect ICT Solutions, Inc., making them an integral part of this report.

FINDINGS :

- In October 3, 2025, The City Government of Bacoor and Neo-Connect ICT Solutions, Inc. (NCIS) entered into a Memorandum of Agreement (MOA) whereas it indicated that the former establish several programs for the purpose of providing financial assistance, livelihood grants, and other social services to all qualified residents of the City of Bacoor and the latter shall provide, at no cost, a premium service of developing and operating the necessary platform that will allow:
 1. The registration, whether online or offline, of the City Government, as well as residents of the city, who are qualified to receive the benefits of the programs
 2. Submission of digital copies of the supporting documents required for the registration
 3. Issuance of both a virtual and physical card to enable the disbursement of electronic money (e-money) to the City Government employees and qualified Program beneficiaries; and
 4. Inclusions of qualified taxpayers and business establishments eligible to receive the benefits of the programs.



- Section 1.B reference to the attached MOA between the City Government of Bacoor and NCIS dictates that NCIS may perform any or all of its obligations under the agreement in a collaborative effort with a third party, but does not relieve it of its primary obligation to the City Government of Bacoor under the agreement.
- G-Xchange, Inc. (GXI), a duly licensed and registered remittance agent, e-money issuer, and a mobile agent solution provider under the GCash brand.
- The City Government of Bacoor and Neo-Connect ICT Solutions, Inc., together with G-Xchange, Inc., are entering into a tripartite agreement to perform certain obligations, specifically the issuance of physical cards capable of facilitating electronic payments from both online and offline transactions, through GXI, subject to a Confidentiality and Non-Disclosure Agreement.
- Confidential information may be shared or disclosed by each of the parties mentioned in connection with the purpose and objective of the Tripartite Agreement.
- Confidentiality and Non-Disclosure Agreement covers all Confidential Information received or obtained by both parties prior to and subsequent to the date of the execution of the agreement.

RECOMMENDATION :

Following careful analysis and deliberation, the Committee on Information and Communications Technology Chairperson, Hon. Adrielito G. Gawaran recommends the **approval** of the resolution authorizing the City Mayor to sign a Tripartite Agreement and Non-Disclosure Agreement among the City Government Of Bacoor, Neo-Connect ICT and G-Xchange, Inc. regarding the use of ESR card.
