Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A DEED OF DONATION ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH BORLAND DEVELOPMENT CORPORATION PERTAINING TO THE DONATION OF ROAD LOTS AND OPEN SPACES IN SUMMERHILL TOWNHOMES SUBDIVISION PHASE 4 TO THE CITY GOVERNMENT OF BACOOR. (PCR 369-2026 dated February 11, 2026)

This committee report pertains to the committee hearing conducted on February 19, 2026 relative to the above-stated subject matter. The hearing was presided over by the Chairperson of the Committee on Housing, Land Utilization and Urban Development, Hon. Horacio M. Brillantes Jr. and was held at the Sangguniang Panlungsod Session Hall situated on the 6th Floor of the BLDR Building, Bacoor Government Center, Barangay Bayanan, Bacoor City, Cavite. The minutes, attendance sheets, and pictures taken during the said hearing are attached hereto and shall be made integral parts of this report.

FINDINGS:

After careful evaluation of the documents and deliberation during the Committee's review, the following findings are hereby presented:

- Authority to accept and sign the Deed of Donation has already been granted under Resolution No. 470, Series of 2024;
- The properties subject of the present endorsement are the same properties previously authorized;



- The remaining requirements involve compliance with documentary submissions and inspection conditions;
- No further legislative action is required from the Sangguniang Panlungsod.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommends the removal from the agenda of the Proposed City Resolution, there being an existing Resolution No. 470, Series of 2024, which already granted authority to the City Mayor to accept and sign the Deed of Donation covering the same properties, and considering that no further legislative action is required from the Sanggunian.
