The 30th regular session of the 6th Sangguniang Panlungsod was held on February 16, 2026 at 10:00 am. It was presided over by Vice Mayor Rowena Bautista-Mendiola. The above subject matter was referred to the to the Committee on Public Works and Highways, chaired by Hon. Levy M. Tela.

**FINDINGS:**

The Department of Public Works and Highways (DPWH) – Cavite 3rd District Engineering Office has allocated the amount of Thirty-Six Million Pesos (PHP 36,000,000.00) intended for the construction of the Bacoor Elementary School;

The said amount shall be transferred to the City Government of Bacoor through a Memorandum of Agreement (MOA) among the City Government of Bacoor, DPWH – Cavite 3rd District Engineering Office, and the Department of Education (DepEd) for the proper implementation of the project.

In accordance with Republic Act No. 12009 and its Implementing Rules and Regulations (IRR), the DPWH, DepEd, and the LGU have reached a mutual agreement to sign a Memorandum of Agreement (MOA) allowing the LGU to carry out the projects, carry out the necessary procurement, and guarantee the successful execution of the projects until their complete and final completion.


**RECOMMENDATION:**



