Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT AND TOLENTINO PARADISE MEMORIAL SERVICES COMPANY FOR THE PURPOSE OF EXTENDING FUNERAL SERVICES TO INDIGENT RESIDENTS OF THE CITY OF BACOOR AS WELL AS TO PUBLIC SCHOOL EMPLOYEES AND LOCAL GOVERNMENT EMPLOYEES. (PCR 383-2026 dated February 23, 2026)

This committee report pertains to the committee hearing conducted on March 5, 2026 relative to the above-stated subject matter. The hearing was presided over by the Chairperson of the Committee on Social Services, Hon. Horacio M. Brillantes Jr. and was held at the Sangguniang Panlungsod Session Hall situated on the 6th Floor of the BLDR Building, Bacoor Government Center, Barangay Bayanan, Bacoor City, Cavite. The minutes, attendance sheets, and pictures taken during the said hearing are attached hereto and shall be made integral parts of this report.

FINDINGS:

After careful evaluation of the documents and deliberation during the Committee's review, the following findings are hereby presented:

- The Office of the City Mayor endorsed to the Sangguniang Panlungsod the request for the passage of a City Resolution authorizing the Honorable City Mayor to enter into and sign a Memorandum of Agreement with Tolentino Paradise Memorial Services Company.
- The proposed Memorandum of Agreement seeks to formalize the partnership between the City Government of Bacoor and Tolentino Paradise Memorial



Services Company and to establish the terms, conditions, and responsibilities of the parties relative to the services to be provided.

- The Committee examined the provisions of the proposed Memorandum of Agreement and found the same to be sufficient in defining the scope, obligations, and responsibilities of the parties concerned.
- The execution of the proposed Memorandum of Agreement requires the authority of the Sangguniang Panlungsod in order to authorize the City Mayor to enter into the same on behalf of the City Government of Bacoor.

RECOMMENDATION:

In view of the foregoing, the Committee hereby recommends the **APPROVAL** of the Proposed City Resolution: Authorizing the Honorable City Mayor, Strike B. Revilla, to enter into and sign the Memorandum of Agreement with Tolentino Paradise Memorial Services Company, subject to compliance with existing laws, rules, and regulations.
