**Subject:** *"A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. The draft Memorandum of Agreement and Resolution was reviewed by the committee and was found to be beneficial to the concerned minors of the City of Bacoor.

**FINDINGS:**

The City Government of Bacoor is committed to provide social welfare services, which include programs and projects on child and youth welfare, family and community welfare, and provision of proper development and welfare of children in the barangay by promoting and supporting activities for the protection and total development of children, including responding to the needs of Children in Need of Special Protection (CNSP) within its locality. The committee considered Section 17 of the Republic Act No. 7160 otherwise known as the Local Government Code of 1991, and LGU Bacoor likewise, desires and is willing to assist the National Authority for Child Care (NACC)-Regional Alternative Child Care Office (RACCO) in the fulfillment of UPPGH-CPU goals and encouraged partnerships in the barangays with programs that addresses the needs and concerns of children believed to have been abused.
