This report pertains to the request from the Office of the Human Resources Development and Management Department (HRDMD) for a City Resolution concurring the appointment of Engr. Reynaldo L. Hapa as the City Government Department Head I under the City Assessor's Department of the City Government of Bacoor effective March 16, 2026, in compliance with the documentary requirements of the Civil Service Commission (CSC).

The said subject matter was referred to this Committee by the Presiding Officer, Hon. Rowena Bautista-Mendiola, during the 32nd Regular Session of the 6th Sangguniang Panlungsod on March 02, 2026.

As the new head of the said department, Engr. Hapa's office is responsible for discovering, listing, appraising, and assessing all real property (land, buildings, machinery) within its jurisdiction for tax purposes. They also maintain tax maps, update property ownership records, and issue tax declarations.

In view of the foregoing, the Committee respectfully recommends to the Sangguniang Panlungsod **TO PASS** a resolution concurring the appointment of Engr. Reynaldo L.
