**Subject: LETTER OF COMPLAINT FROM THE CONCERNED RESIDENTS OF BARANGAY TALABA 2 AGAINST PUNONG BARANGAY RODOLFO BAÑAS FOR THE ALLEGED ALTERATION OF BARANGAY BOUNDARIES BETWEEN BARANGAY TALABA 1 AND TALABA 2 WITHOUT DUE PROCESS. (PC0 394-2026 dated March 09, 2026)**

This report pertains to the complaint filed by the concerned residents of Barangay Talaba 2 against Punong Barangay Rodolfo Bañas involving the alleged alteration of barangay boundaries between Barangay Talaba 1 and Talaba 2 without due process.

The said complaint was referred to this Committee by the Presiding Officer, Hon. Rowena Bautista Mendiola, during the 33<sup>rd</sup> Regular Session of the 6<sup>th</sup> Sangguniang Panlungsod on March 09, 2026 for appropriate action.

After a thorough review of the documents submitted, Committee Vice Chair Reynaldo D. Palabrica informed the council that the said complaint was already discussed and resolved with the concerned parties and the City Mayor, Hon. Strike B. Revilla which means that the allegation about the alteration of the boundaries of the said barangays without due process is already moot. He also requested SP Secretary Atty. Khalid Atega Jr. to inform the complainant that the issue was already resolved.

**RECOMMENDATION**

In view thereof, the Committee respectfully recommends to remove the above mentioned subject matter from the Council's next Order of Business. The motion met no objection and was unanimously seconded by the Council members. It was deemed approved by the Chair.
