Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT (SISTERHOOD AGREEMENT) BETWEEN THE CITY GOVERNMENT OF BACOOR AND THE CITY GOVERNMENT OF MUNTINLUPA. (PCR 404-2026, dated 16 March 2026)

The above-captioned proposed resolution was referred to the Committee on Tourism, Culture, Arts, and External Linkages, chaired by Hon. Ricardo F. Ugalde during the 34th Regular Session of the 6th Sangguniang Panlungsod held on 16 March 2026.

The proposed measure seeks to authorize the City Mayor to enter into a Sisterhood Agreement with the City Government of Muntinlupa as a mechanism for inter-local cooperation pursuant to the Local Government Code of 1991 and its implementing rules for its strong ecotourism practices, environmental sustainability programs, disaster resilience strategies, and cultural preservation initiatives. The proposed partnership is expected to facilitate the exchange of knowledge, technical expertise, and best practices between the two local government units, particularly in the areas of tourism development, environmental management, cultural promotion, and community resilience.

FINDINGS:

During the Joint Committee Hearing conducted on 26 March 2026, no objection was raised on the said proposed resolution.

After due deliberation, the Committee finds that the proposed Sisterhood Agreement between the City Government of Bacoor and the City Government of Muntinlupa is beneficial and advantageous to both Local Government Units.

The Committee further finds that the proposed agreement will promote inter-local collaboration and provide opportunities for the exchange of programs, and policies.

Moreover, the Committee finds that the proposed agreement is consistent with the provisions of the Local Government Code of 1991 and is aligned with the development objectives of the City Government of Bacoor.





RECOMMENDATION:

Based on the foregoing findings, the Joint Committees hereby recommend the **APPROVAL** of the proposed resolution entitled:

"A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT (SISTERHOOD AGREEMENT) BETWEEN THE CITY GOVERNMENT OF BACOOR AND THE CITY GOVERNMENT OF MUNTINLUPA."
