Subject: *A RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF BINAKAYAN MABOLO TALABA ZAPOTE PUBLIC UTILITY JEEPNEY DRIVERS - OPERATORS ASSOCIATION (BMTZPUJDOA), INC. AS A NON-GOVERNMENT ORGANIZATION (NGO) IN THE CITY OF BACOR, PROVINCE OF CAVITE. (PCR 407-2026 dated March 23, 2026).*

During the 35th Regular Session of the 5th Sangguniang Panlungsod on March 23, 2026 at the Sangguniang Panlungsod Session Hall and was presided over by Hon. Rowena Bautista – Mendiola. The above-mentioned subject was referred to the Committee on Non-Government Organization.

FINDINGS:

Upon review, it was noted that the submitted requirements lack the necessary endorsement from the Bacoor Traffic Management Department (BTMD). The aforementioned organization continued to fail to submit in spite of multiple follow-ups.

The said endorsement is based on the City Ordinance No. 424-2025, "An Ordinance Amending and Modifying Section of City Ordinance No. 294-2023 Series of 2023 Otherwise Known as the "Bacoor City NGO Accreditation Ordinance".

Section 1. Section 5 of City Ordinance No. CO 294-2023 Series of 2023 is hereby amended and shall henceforth read as follows:

Section 5: Requirement of Accreditation – Before entering into any partnership or undertaking any project, program or activity with the City Government of Bacoor or with any Barangays within the City, all NGOs, Pos and Cos must first be duly accredited by the Sangguniang Panlungsod. Accreditation shall be granted based on the fulfillment of the said organizations of the standards provided in Section 6 of CO 294-2023 Series of 2023.

The accreditation documents submitted by all the NGOs, POs and CSOs shall be reviewed, approved, and endorsed by the various departments or units of the City Government of Bacoor, which shall include the Housing and Urban Development and Resettlements Department (HUDRD) duly authorized for that purpose in the Implementing Rules and Regulations of this Ordinance before submission to the Sangguniang Panlungsod.

Non-compliance with the requirement of accreditation and without the required endorsement from the authorized departments or units of the City Government of Bacoor shall be grounds for the disqualification of the NGO, PO or CSO concerned from partnering with the City Government.

RECOMMENDATION:

AS A NON-GOVERNMENT ORGANIZATION (NGO) IN THE CITY OF BACOR, PROVINCE OF CAVITE.." be **TEMPORARILY ARCHIVED**.
