Subject: PCR 414-2026 – A RESOLUTION AMENDING CITY RESOLUTION NO. 2026-966 PARTICULARLY THE NAME OF THE SERVICE PROVIDER INDICATED THEREIN FROM “ARB LOGOGRAPHY” TO “CRISTORA ENTERPRISE”. (dated 30 March 2026).

The aforementioned proposed city resolution was endorsed by the City Administrator's Office to the Sangguniang Panlungsod on March 19, 2026 together with the letter from the E-Governance Department requesting the above-said subject.

FINDINGS :

The Committee on Information and Communications Technology requested the Bids and Awards Committee (BAC), through a letter dated April 15, 2026, to provide supplemental documents to validate Cristora Enterprise as the winning bidder for the RFID Attendance Monitoring System project. The said project was initially awarded to ARB Logography. On April 22, 2026, the committee received a letter from BAC clarifying Cristora Enterprise as the winning bidder and formally submitted the BAC Resolution, Notice of Award, and Notice to Proceed approved by the City Mayor. These supplemental documents are attached to this report.

RECOMMENDATION :

Following careful analysis and deliberation, the Chairperson of the Committee on Information and Communications Technology, Hon. Adrielito G. Gawaran, recommends the **approval** of the amendment to City Resolution 2026-966, given that the Notice to Award and Notice to Proceed have already been issued to Cristora Enterprise.
