Subject: *(PCR 426-2026) BARANGAY ORDINANCE NO. 02-2026 ENTITLED: "AN ORDINANCE ADOPTING AND IMPLEMENTING THE PROVISIONS OF THE REVISED ENVIRONMENT CODE OF THE CITY OF BACOOR AND REPUBLIC ACT NO. 9003, PROHIBITING THE OPEN BURNING OF SOLID WASTES WITHIN BARANGAY SALINAS 2 AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF." (Date referred April 06, 2026).*

The Committee has observed that the amount stated in the penalty clause exceeds the limits prescribed by existing laws, and that the inclusion of imprisonment as a penalty is beyond the authority of the Sangguniang Barangay. Under the Local Government Code of 1991 (R.A. 7160), barangays are not empowered to impose penalties exceeding the maximum amounts and are not authorized to impose imprisonment.

In view of these findings, the Committee recommends that the Barangay Council of Aniban I review and amend the said ordinance to align its penalty provisions with what is lawfully prescribed under national laws and guidelines.

AN ORDINANCE ADOPTING AND IMPLEMENTING THE PROVISIONS OF THE REVISED ENVIRONMENT CODE OF THE CITY OF BACOOR AND R.A. 9003, PROHIBITING THE OPEN BURNING OF SOLID WASTES WITHIN BARANGAY SALINAS 2 AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

HON. PUNONG BARANGAY

SECTION 1. Title. This Ordinance shall be known as the "Anti-Open Burning Ordinance of Barangay Salinas 2" concerning risk, health and safety because it releases toxic substance and acts as a fire hazard.

SECTION 2. Legal Basis. This ordinance is based on Republic Act No. 9003 (Ecological Solid Waste Management Act of 2000), which prohibits the open burning of solid waste and the Revised Environment Code of the City of Bacoor (City Ordinance No. 438-2025).

SECTION 3. Prohibited Acts. It shall be unlawful for any person, household, or establishment within the jurisdiction of this Barangay to engage in the open burning of solid waste including but not limited to:

- Dry leaves, twigs, and yard waste
- Plastics, rubber, and other hazardous materials
- Household garbage and commercial refuse

SECTION 4. Fines and Penalties. In accordance with the uniform procedure of the City of Bacoor (City Ordinance No. 228-2022), violators may be issued an Ordinance Violation Receipt (OVR).

- **First Offense:** Fine of P500.00 or community service (at the city-wide standards for minor environmental violations)
- **Second Offense:** Fine of P1,000.00
- **Third Offense:** Higher fines or imprisonment as determined by the court, or administrative penalties

SECTION 5. ENFORCEMENT. The Barangay Solid Waste Management Committee and Barangay Tanods are hereby deputized to monitor and report violations to the City Environment Services Department (CESD).

SECTION 6. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval and posting in at least three (3) conspicuous places in the Barangay.






