Subject: (PCR 427-2026) BARANGAY ORDINANCE NO. 04-2026 ENTITLED: "AN ORDINANCE ADOPTING CITY ORDINANCE NO. 228-2022 AND 3 PROHIBITING PERSONS FROM APPEARING NAKED OR HALF-NAKED IN PUBLIC PLACES WITHIN THE JURISDICTION OF BARANGAY SALINAS 2 AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF". (Date referred April 6, 2026)

The Committee has observed that the amount stated in the penalty clause exceeds the limits prescribed by existing laws, and that the inclusion of imprisonment as a penalty is beyond the authority of the Sangguniang Barangay. Under the Local Government Code of 1991 (R.A. 7160), barangays are not empowered to impose penalties exceeding the maximum amounts, and kindly elaborate on the legal action said in the Proposed Ordinance.

In view of these findings, the Committee recommends that the Barangay Council of Salinas 2 review and amend the said ordinance to align its penalty provisions with what is lawfully prescribed under national laws and guidelines.

AN ORDINANCE ADOPTING CITY ORDINANCE NO. 228-2022 AND PROHIBITING PERSONS FROM APPEARING NAKED OR HALF-NAKED IN PUBLIC PLACES WITHIN THE JURISDICTION OF BARANGAY SALINAS 2, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government unit shall exercise powers essential to the promotion of the general welfare and public morals;

WHEREAS, the City of Bacoor has enacted measures to maintain public decency and orderliness in all public spaces;

WHEREAS, the Sangguniang Barangay of Salinas 2 recognizes that roaming around public places half-naked or without proper upper apparel erodes decency and sets a poor example for the youth;

NOW THEREFORE, on motion of Kagawad John Marvin S. Sibal, unanimously seconded by the members present, **BE IT ORDAINED BY THE SANGGUNIANG BARANGAY OF SALINAS 2, CITY OF BACOOR, IN SESSION ASSEMBLED, THAT:**

SECTION 1. SHORT TITLE. This Ordinance shall be known as the "Barangay Salinas 2 Public Decency Ordinance."

SECTION 2. DEFINITION OF TERMS.

- **Half-Naked:** Refers to a person appearing in public without any top apparel or upper garment (e.g., shirt, T-shirt or blouse) to cover the upper portion of the body.
- **Public Places:** Includes streets, alleys, parks, plazas, public markets and other areas accessible to the general public.

SECTION 3. PROHIBITION. It shall be unlawful for any person to display themselves or roam around in public places within the territorial jurisdiction of this Barangay while naked or half-naked.

SECTION 4. PENALTIES. In accordance with the Uniform Implementation Procedure Ordinance of Bacoor (City Ordinance No. 228-2022), violators shall be subject to the following:

- 1st offense: Fine of P 500.00 or mandatory community service.
- 2nd offense: Fine of P 1,000.00 and/or attendance at a decency seminar.
- 3rd offense: Maximum fine allowed by law or referral to the proper authorities for legal action.


SECTION 5. SEPARABILITY CLAUSE. If any provision of this ordinance is declared invalid, the remaining portions shall continue to be in full force and effect.

SECTION 6. REPEALING CLAUSE. All previous Barangay ordinances or resolutions inconsistent with this measure are hereby repealed or modified accordingly.

SECTION 7. EFFECTIVITY. This ordinance shall take effect two days after its posting in at least three (3) conspicuous places within the Barangay.




