Subject: (FROM BARANGAY MAMBOG 3) BARANGAY RESOLUTION NO. 1, SERIES OF 2026 ENTITLED: " A RESOLUTION APPROVING THE FIVE (5) -YEAR PLAN OF THE BARANGAY DISASTER RISK REDUCTION AND MANAGEMENT COMMITTEE ON THE UTILIZATION OF UNEXPENDED BALANCES OF THE 2023-2025 BARANGAY DISASTER RISK REDUCTION MANAGEMENT FUND AMOUNTING TO NINE HUNDRED EIGHTEEN THOUSAND ONE HUNDRED NINETY-SIX PESOS AND SEVENTY-FOUR CENTAVOS (PHp918,196.74)" - PCR 456-2026 dated May 4, 2026

Referred to this Committee on the 41st Regular Session of the 6th Sangguniang Panlungsod the above-subject matter for appropriate action and recommendation.

The Local Disaster Risk Reduction and Management Fund (LDRRMF) are intended to be used for disaster prevention, mitigation, preparedness, response, rehabilitation and recovery, the following:

- Purchasing early warning systems
- Acquiring preparedness equipment
- Buying life-saving rescue equipment, supplies, and medicines
- Training
- Paying premiums for calamity insurance
- Post-disaster activities

As required for the utilization of unexpended balances of the Barangay Disaster Risk Reduction Management Fund, the Barangay approved and submitted its Resolution No. 1, Series of 2026 covering the Five-Year 2023-2026.

The Joint Committee referred to the processes and procedures established by the City Accountant Office and City Budget Office with the preceding approved request for the utilization of unexpended balance of LDRRM Fund, as follows:

- The unutilized LDRRM Fund is part of the barangay savings, a trust fund, in the current year. The trust fund can be re-programmed to related projects.
- The request of the Barangay to utilize the unexpended balance of fund, as a trust fund, covers the Five-Plan 2023- 2025 is allowable.
- The unutilized risk reduction and management fund within the period of five years, as a trust fund, can be utilized by the barangay as long as there is a **disaster risk reduction plan**, as per the advice of the Auditor of the Commission On Audit, Bacoor City and the Head of Bacoor Disaster Risk Reduction and Management Office,
- The submission of a supplemental budget to be processed by the City Budget Office is no longer required considering that it is a trust fund. The subject matter falls under the processing of the City Accounting Office.
- The request of the Barangay to utilize the unexpended fund is a continuing process as long as there is savings based on the record of the City Accounting Office and until the balances of which are expended and the programs are properly documented.
- The Barangay Disaster Risk Reduction Management Plan for the purpose has been submitted.

RECOMMENDATION:

In view of the foregoing, and considering that the existing law allows the utilization of unexpended Local Risk Reduction and Management Fund covering the current year, the Honorable Members of the Committee hereby recommend **TO APPROVE** the Barangay Resolution No. 1, Series of 2026 of Barangay **MABOG 3**, Bacoor City, subject to existing laws and DBM/DILG circulars and issuances, accounting and auditing rules and regulation, with the following purposes:

- Adopting the Five-Year Plan covering the period 2023=2025 of the Barangay Risk Reduction and Management Committee for the purpose of utilizing the unexpended balances of the LDRRM Fund.
- To utilize the unexpended LDRRM Fund of the Barangay amounting to **NINE HUNDRED EIGHTEEN THOUSAND ONE HUNDRED NINETY-SIX PESOS AND SEVENTY-FOUR CENTAVOS (PHp918,196.74)**.

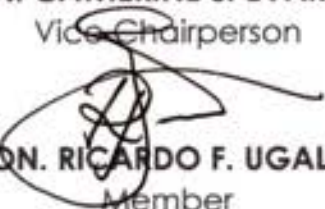

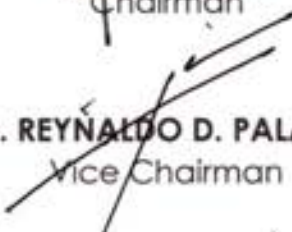
