Subject: A RESOLUTION APPROVING THE SUPPLEMENTAL BARANGAY YOUTH INVESTMENT PROGRAM NO. 1 (SBYIP #1) AND SUPPLEMENTAL BUDGET NO. 1 (SB# 1) OF THE SANGGUNIANG KABATAAN OF BARANGAY P.F. ESPIRITU 4, CITY OF BACOR, CAVITE FOR FISCAL YEAR 2026. **PCR 478 – 2026** dated June 15, 2026

Referred to this Committee the 47th Sangguniang Panlungsod the above-subject matter for appropriate action and recommendation.

BARANGAY P.F. ESPIRITU IV

SANGGUNIANG KABATAAN SUPPLEMENTAL INVESTMENT PROGRAM NO. 1

The proposed **Supplemental Barangay Youth Investment Program (SBYIP) No. 1** and **Supplemental Budget No. 1** of the Sangguniang Kabataan of **Barangay P.F. Espiritu IV** have been endorsed, examined and reviewed by the City Budget Department and found to be in conformity with the provisions of the DBM-DILG-NYC Joint Memorandum Circular No. 1, Series of 2019, and other applicable laws, rules and regulations.

During the committee hearing, the resource person from the City Budget Department was invited to clarify and verify the following:

- The Sangguniang Kabataan of **Barangay P.F. Espiritu IV** has an available Beginning Balance (Unappropriated Surplus) amounting to **SEVEN HUNDRED FORTY THOUSAND PESOS (Php740,000.00)**, which serves as the funding source for Supplemental Budget No. 1.
- The total amount appropriated under Supplemental Budget No. 1 is **SEVEN HUNDRED FORTY THOUSAND PESOS (Php740,000.00)**, which does not exceed the available funding source.



- The proposed Supplemental Barangay Youth Investment Program allocates **TWO HUNDRED FORTY THOUSAND PESOS (Php240,000.00)** for Capacity Building Programs, Leadership Trainings, Conferences and Seminars, and **FIVE HUNDRED THOUSAND PESOS (Php500,000.00)** for Sports Development Activities and the Purchase of Sports Supplies and Materials.
- The proposed programs and activities are intended to strengthen youth leadership, participation, capability development, and sports development within the barangay.

SANGGUNIANG KABATAAN SUPPLEMENTAL BUDGET NO. 1

The attached documents to support the proposed Supplemental Budget No. 1 of the Sangguniang Kabataan of **Barangay P.F. Espiritu IV** will readily show that it has been examined and reviewed by the concerned City Accounting and Internal Audit Department and City Budget Department, and that the same is in conformity with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.

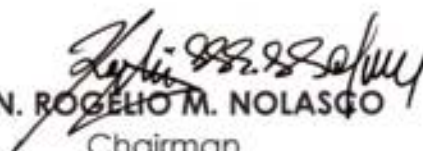
