Subject: A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PLAN NO. 1 (SIP #1) AND SUPPLEMENTAL BUDGET NO. 1 (SB# 1) OF BARANGAY MAMBOG 3, CITY OF BACOR, CAVITE FOR FISCAL YEAR 2026. - **PCR 480 – 2026** dated June 15, 2026

Referred to this Committee on the 47th Regular Session of the 6th Sangguniang Panlungsod the above-subject matter for appropriate action and recommendation.

BARANGAY MAMBOG III

SUPPLEMENTAL INVESTMENT PROGRAM NO. 1

The proposed Supplemental Investment Program (SIP) for Supplemental Budget No. 1 of **Barangay MAMBOG III** has been examined and reviewed by the City Budget Office and the same is consistent with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.

During the committee hearing, the resource persons from the City Planning and Development Coordinator Office, City Accounting Office and City Budget Department were invited, and properly clarified and verified the following:

- Barangay **MAMBOG III** has available savings amounting to **TWO MILLION PESOS (Php2,000,000.00)** derived from completed projects and activities under the General Fund.
- The proposed Supplemental Budget No. 1 allocates **ONE MILLION FIVE HUNDRED THOUSAND PESOS (Php1,500,000.00)** for the purchase of larvicide intended for mosquito-control and disease-prevention activities within the barangay.
- The proposed Supplemental Budget No. 1 further allocates **TWO HUNDRED FIFTY THOUSAND PESOS (Php250,000.00)** for the purchase of computers and printers to improve barangay operations and administrative efficiency.

- The proposed Supplemental Budget No. 1 likewise allocates **TWO HUNDRED FIFTY THOUSAND PESOS (Php250,000.00)** under Capital Outlay for the purchase of air-conditioning units for barangay facilities.
- The proposed appropriations are included in the duly approved FY 2026 Annual Investment Program of the barangay.

SUPPLEMENTAL BUDGET NO.1

The attached documents to support the proposed Supplemental Budget No. 1 of Barangay **MAMBOG III** will readily show that it has been examined and reviewed by the concerned City Accounting and Internal Audit Department and City Budget Department, and that the same is in conformity with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.

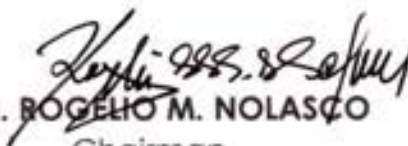
