Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE REVISED MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE IV-A CALABARZON ON BEHALF OF THE CITY GOVERNMENT OF BACOR PERTAINING TO THE SUSTAINABLE LIVELIHOOD PROGRAM. (PCR 505-2026 dated July 6, 2026)

This committee report pertains to the committee hearing conducted on July 16, 2026 relative to the above-stated subject matter. The hearing was presided over by the Chairperson of the Committee on Social Services, Hon. Horacio M. Brillantes Jr. and was held at the Sangguniang Panlungsod Session Hall situated on the 6th Floor of the BLDR Building, Bacoor Government Center, Barangay Bayanan, Bacoor City, Cavite. The minutes, attendance sheets, and pictures taken during the said hearing are attached hereto and shall be made integral parts of this report.

FINDINGS:

After careful evaluation of the documents and deliberation during the Committee's review, the following findings are hereby presented:

- The proposed Memorandum of Agreement is a renewal of the previous agreement between the City Government of Bacoor and the DSWD, which had already expired, thereby necessitating the execution of a revised MOA to ensure the continuous implementation of the Sustainable Livelihood Program (SLP).

- The DSWD emphasized that the partnership between the national government and the local government is essential in effectively implementing livelihood programs and extending assistance to qualified beneficiaries within the City of Bacoor.
- The City Social Welfare and Development Department expressed its support for the proposed MOA, recognizing that its approval would provide greater opportunities for Bacoor residents to benefit from the Sustainable Livelihood Program.
- The Office of the City Legal Service represented by Atty. Salve Valenciano manifested that it has no legal objection to the execution of the proposed Memorandum of Agreement, subject to the correction of clerical and formatting errors identified in the draft, including the duplication of certain provisions.
- The DSWD committed to correcting the identified errors in the draft Memorandum of Agreement prior to its execution.
- During the deliberation, it was clarified that the Sustainable Livelihood Program consists of the Microenterprise Development Track and the Employment Facilitation Track, providing beneficiaries with opportunities for livelihood assistance, entrepreneurship, employment training, and employment support services.
- The Committee likewise noted that the locally funded Seed Capital Assistance presently ranges from ₱10,000.00 up to ₱20,000.00, depending on the viability and requirements of the proposed livelihood project.
- The Committee further agreed to include the Specific Implementation Agreement (SIA) together with the Memorandum of Agreement in the proposed Resolution to facilitate a more comprehensive approval by the Sangguniang Panlungsod.

RECOMMENDATION:

In view of the foregoing findings, the Committee finds the objectives of the proposed measure to be beneficial in strengthening the partnership between the City
