The committee hearing was held on July 16, 2026, at 3:30 PM at the 6th-floor Sangguniang Panlungsod Session Hall, Bacoor Legislative & Disaster Resilience Building, Bacoor Government Center, Bacoor Boulevard, Brgy. Bayanan, City of Bacoor, Cavite. It was presided over by Chairman Hon. Randy C. Francisco, Committee on Barangay Affairs.

FINDINGS:

1. Gasoline Stations pose significant local impacts on public health and the environment. This includes toxic/carcinogenic air contamination, surface water runoff, leaking underground storage tanks, and more.
2. New gasoline stations frequently add to local traffic congestion and safety issues.
3. After the meeting of the Barangay P.F 5 barangay council, the barangay captain (Mr. Rafael Paterno III) decided to withdraw the ordinance for **Further Study**.

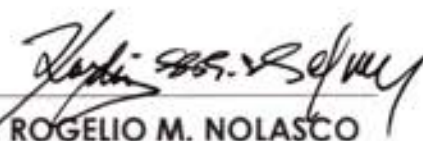
