COMMITTEE REPORT NO. FBA2-127- S-2026 (6th SP)

Subject: **A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 (SIP #1) AND SUPPLEMENTAL BUDGET NO. 1 (SB# 1) OF BARANGAY HABAY 1, CITY OF BACOR, CAVITE FOR FISCAL YEAR 2026.** PCR 513-2026 dated July 6, 2026

Referred to this Committee on the 50th Regular Session of the 6th Sangguniang Panlungsod the above-subject matter for appropriate action and recommendation.

BARANGAY HABAY 1

SUPPLEMENTAL INVESTMENT PROGRAM NO. 1

The proposed Supplemental Investment Program (SIP) No. 1 of **Barangay HABAY 1** has been examined and reviewed by the City Budget Office and was found to be in conformity with the provisions of **Republic Act No. 7160** and existing budgetary rules, regulations, and issuances.

During the committee hearing, the resource persons from the City Planning and Development Coordinator Office, City Accounting and Internal Audit Department and City Budget Department were invited, and properly clarified and verified the following:

- Barangay HABAY 1 have available savings amounting to **TWO MILLION FIVE HUNDRED THOUSAND PESOS (P2,500,000.00).**
- The proposed appropriations under **Personal Services** shall provide **Service Recognition Incentive (SRI)** for qualified barangay personnel, while the appropriations under Maintenance and Other Operating Expenses (MOOE) shall augment the provision for fuel, oil and lubricants to sustain barangay operations until the end of Fiscal Year 2026.
- The proposed appropriations under **Capital Outlay** include the construction of boundary markers and the construction of road and drainage canal at Bagong Kalye. During the deliberation, the Barangay explained that the additional appropriation for the construction of boundary markers is intended to supplement



the existing allocation for the installation of four (4) boundary markers, subject to the final project cost to be determined by the City Engineering Office. Any remaining balance shall revert to the General Fund in accordance with existing accounting and auditing rules and regulations.

- The Committee likewise noted the continuing implementation of road and drainage improvement projects of **Barangay HABAY I**, which are intended to improve public infrastructure and service delivery within the barangay.

SUPPLEMENTAL BUDGET NO.1

The attached documents to support the proposed Supplemental Budget No. 1 of **Barangay HABAY I** readily show that it has been examined and reviewed by the concerned City Accounting and Internal Audit Department and City Budget Department, and that the same is in conformity with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.

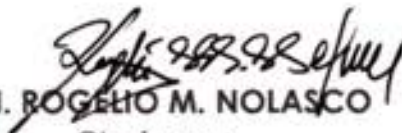
RECOMMENDATION:
