

EXECUTIVE ORDER No. 0.3 Series of 2023

AN ORDER ADOPTING THE IMPLEMENTING RULES AND REGULATIONS OF CITY ORDINANCE NO. 251-2022, OTHERWISE KNOWN AS THE "DESIGNATED SURVIVOR ORDINANCE OF BACOOR"

WHEREAS, Section 16 of R.A. No. 7160 provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare...xxx;

WHEREAS, on December 12, 2022, the Sangguniang Panlungsod enacted and passed City Ordinance No. 251-2022, otherwise known as the "Designated Survivor Ordinance of Bacoor;"

WHEREAS, the City Government of Bacoor recognizes the need to issue an Implementing Rules and Regulations pertinent to the above-mentioned Ordinance;

WHEREAS, the Office of the City Mayor of Bacoor, in coordination with the Bacoor Disaster Risk and Reduction Management Office, issued the above-mentioned Implementing Rules and Regulations that shall govern the "Designated Survivor Ordinance of Bacoor;"

NOW, THEREFORE, I, STRIKE B. REVILLA, City Mayor of Bacoor, Cavite, by virtue of the powers vested in me by law, do hereby order for the adoption and implementation of the Implementing Rules and Regulations of City Ordinance No. 251-2022 herein attached.

Section 1. Implementing Rules and Regulations (IRR).


Attached herein is the Implementing Rules and Regulations of City Ordinance No. 251-2022 which shall form part of this Executive Order. This shall be known as the "Implementing Rules and Regulations of the Designated Survivor Ordinance of Bacoor.

All affected offices and departments are hereby ordered to adopt the said implementing rules and regulations and be guided accordingly.

Strict compliance and observance of all city government officials and employees to this IRR is hereby ordered.

Section 2. Repealing Clause.

All previously issued orders and directives inconsistent with any provision found herein shall be deemed repealed, revoked or amended accordingly.







Section 3. Separability Clause.

In the event that any provision found herein shall be judicially or administratively declared illegal or infirm, the remaining provisions shall remain in full force and effect.

Section 4. Effectivity Clause.

This Executive Order shall take effect immediately upon its signing and remain in full force and effect until repealed, revoked or amended accordingly.

IMPLEMENTING RULES AND REGULATIONS OF CITY ORDINANCE NO. 251-2022

AN ORDINANCE PROVIDING A SYSTEM OF SUCCESSION AMONG CITY
OFFICIALS OF THE CITY OF BACOOR, CAVITE TO PRESERVE THE LEADERSHIP
STRUCTURE OF THE CITY DISASTER RISK REDUCTION AND MANAGEMENT
COUNCIL (CDRRMC) DURING DISASTERS AND PROVIDING PENALTIES FOR
VIOLATIONS HEREOF TO BE KNOWN AS THE "DESIGNATED SURVIVOR
ORDINANCE OF BACOOR"

Section 1. Title and Enactment. – The City Ordinance No. 251-2022, otherwise known as the "Designated Survivor Ordinance of Bacoor" is approved and enacted. The Implementing Rules and Regulations, hereinafter called the IRR, is promulgated pursuant to City Ordinance No. 251-2022 for the purpose of prescribing the necessary rules and regulations to rationalize and strengthen the policy regarding the Designated Survivor Ordinance of Bacoor.

Section 2. The Designated Survivor Rule. - The City Mayor, Vice Mayor and the Members of the Sangguniang Panlungsod shall not:

- a. Go on leave at the same time or during the same period; or
- All go to a place at the same time where there is an ongoing disaster for whatever reason;
- All go to a same place, even at different times, where there is an ongoing disaster for whatever reason.
- Section 3. Applicable to Department Heads and Units. The Rule mentioned in Section 2 hereof also applies to Head and second highest ranking employee of all departments and units under the Office of the City Mayor.
- Section 4. The Emergency Succession System. In accordance with City Ordinance No. 251-2022, the following rules shall be strictly followed, to wit:
- 4.1. In case the City Mayor dies or is permanently incapacitated during a disaster, the City Vice Mayor shall automatically become the Chairperson of the CDRRMC.
- 4.2. In case the City Vice Mayor dies or is permanently incapacitated during a disaster, the Sangguniang Panlungsod member who garnered the highest number of votes during the last local elections held in the City of Bacoor prior to the occurrence of the said disaster shall automatically become the Chairperson of the CDRRMC.
- 4.3. In case the City Mayor, City Vice Mayor, and the Sanggunian member who garnered the highest number of votes during the last local election dies or is incapacitated during a disaster, the surviving sanggunian member/s that garnered the next highest number of votes during the last local elections held in the City of Bacoor prior to the occurrence of the said disaster shall automatically become the Chairperson of the CDRRMC.

- 4.4. In case the head of a department or unit under the Office of the City Mayor dies or is permanently incapacitated during a disaster, the next highest ranking employee of the said department or unit that survived the disaster shall automatically become the interim head of the said department or unit and shall become an interim member of the CDRRMC until a new department/unit head is appointed.
- Section 5. Penalty. A fine of Five Thousand Pesos (P5,000.00) and render of community service for a period determined by a court of law shall be imposed to any employee or official of the City Government of Bacoor who unjustifiably refuses to comply with the provisions of this Ordinance and its Implementing Rules and Regulations.
- Section 6. Repeal Clause. All existing Ordinances, Implementing Rules and Regulations or parts thereof, Resolutions and Executive Orders that duplicate, in conflict, inconsistent or contravene any of the provisions of City Ordinance No. 251-2022 is hereby repealed, amended and/or modified.
- Section 7. Separability Clause. In case a court of law or court of competent jurisdiction declares any provision of this Ordinance void, contrary to law or unconstitutional, the validity or enforceability of any other provisions of this Ordinance not affected by such declaration shall not be affected and remain in full force and effect.
- Section 10. Rule on Interpretation in Case of Conflict with Filipino Translation. In case of conflict in the interpretation hereof between the English version of this Ordinance and its Filipino translation, the provisions appearing in English shall prevail.
- Section 11. Effectivity. This ordinance shall take effect immediately after it has been posted in at least three (3) conspicuous places within the City of Bacoor, Cavite.
